**RESOLUTION**

1 A RESOLUTION concerning

2 The Washington Suburban Sanitary Commission Fiscal Years

3 2003-2008 Capital Improvements Program

4 for Prince George's County for Water and Sewerage

5 For the purpose of amending the WSSC Fiscal Years 2003-2008 Capital Improvement Program  
6 for Water and Sewerage.

7 WHEREAS, Article 29, Section 7-106 of the Annotated Code of Maryland requires the  
8 Washington Suburban Sanitary Commission (hereinafter "WSSC") to submit a Capital  
9 Improvement Program and any amendments thereto to the County Executive and County  
10 Council of Prince George's County; and

11 WHEREAS, this WSSC Capital Improvement Program is part of the Adopted County  
12 Comprehensive Ten Year Water and Sewerage Plan and contains projects to support water  
13 supply and sewerage system development as proposed in the plan; and

14 WHEREAS, the County Council adopted the "WSSC Capital Improvements Program for  
15 Fiscal Years 2003-2008 and Capital Budget for Fiscal Year 2003" on May 22, 2002 with the  
16 adoption of CR-21-2002; and

17 WHEREAS, Article 29, Section 7-106 of the Annotated Code of Maryland further  
18 provides that after notice to the public and a public hearing, the County Council shall approve,  
19 disapprove or modify the WSSC Capital Improvement Program; and

20 WHEREAS, all other requirements of Article 29, Title 7 of the Annotated Code of  
21 Maryland that concern final action by the Council on the WSSC Capital Improvement Program  
22 for Water Sewerage and for Stormwater management have been met;

1 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County,  
2 Maryland, that the "Capital Improvements Program Fiscal Years 2003-2008 and the Capital  
3 Budget Fiscal Year 2003 for Water and Sewerage" as approved in CR-21-2002 is hereby  
4 amended by the attached Appendix 1.
