#### **BACKGROUND INFORMATION/FISCAL IMPACT:**

This bill will provide a limited authority for land within the R-10 (Multifamily High Density Residential) and R-55 (One-Family Detached Residential) Zones of the County to adaptively redevelop as a mixed use development, provided the land meets certain distance requirements from a line of transit and is approved through site plan review processes.
