**RESOLUTION**

1 A RESOLUTION concerning

2 The Formation of an Agricultural District pursuant to the  
3 Maryland Agricultural Land Preservation Foundation Program

4 For the purpose of recommending that the Maryland Agricultural Land Preservation Foundation  
5 approves the petition of David and Cynthia Brooks to establish an agricultural district, reference  
6 Map 158/Parcel 6/Tax Account 04-0256107.

7 WHEREAS, a district agreement, dated on January 5, 2007, by David and Cynthia Brooks  
8 requested the establishment of an agricultural preservation district for approximately 52.581  
9 acres of land (Map 158/Grid F2/Parcel 6/Tax Account 04-0256107) located at 15200 River  
10 Airport Road in the Brandywine area, as generally shown on the attached location map; and

11 WHEREAS, the petition was referred to the Prince George’s County Agricultural  
12 Preservation Advisory Board and the Prince George’s County Planning Board for review and  
13 recommendation; and

14 WHEREAS, the Prince George’s County Agricultural Preservation Advisory Board found  
15 that the David and Cynthia Brooks property met the qualifying criteria for productivity, size, and  
16 location as set by the Maryland Agricultural Land Preservation Foundation, and recommended  
17 establishment of the agricultural district on February 28, 2007; and

18 WHEREAS, the Prince George’s County Planning Board found that the establishment of  
19 the proposed agricultural district is compatible with existing and approved county plans and  
20 recommended approval of the petition and establishment of the district on April 12, 2007.

21 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
22 County, Maryland, that Map 158/Parcel 6/Tax Account 04-0256107 described in the agricultural

1 district petition filed by David and Cynthia Brooks is recommended to the Maryland Agricultural  
2 Land Preservation Foundation for approval.

3 BE IT FURTHER RESOLVED that this resolution, copies of the petition, maps and copies  
4 of the letters from the Agricultural Preservation Advisory Board and the Prince George’s County  
5 Planning Board, be forwarded by the Clerk of the Council to the County Executive for his  
6 consideration and, upon his approval, transmittal to the Maryland Agricultural Land Preservation  
7 Foundation for appropriate action.
