RESOLUTION

A RESOLUTION concerning

Subregion I Sectional Map Amendment

FOR the purpose of proposing amendments to the Sectional Map Amendment for Planning Areas 60, 61 and 62, which is a comprehensive rezoning proposal for the Beltsville, Calverton, Montpelier and West Laurel areas of Prince George's County, Maryland and the Planning Area Boundary Map.

WHEREAS, on October 2, 1990, the District Council adopted CR-60-1990 which comprehensively zoned Subregion I; and

WHEREAS, on November 6, 1990, by Chapter 624 of the Laws of Maryland, 1990, and passed by referendum of the voters, the Prince George's-Montgomery County boundary line within the Regional District was amended to include all of Map 5, Grid A-1, Parcel 1, Liber 1227, Folio 389, encompassing approximately two (2) acres of

land, into the area of Prince George's County; and

WHEREAS, the Zoning Ordinance for Prince George's County must be amended by adopting a Zoning Map to apply the Zoning Ordinance text to the subject property.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, sitting as the District Council for that part of the Maryland-Washington Regional District in Prince George's County, Maryland, that the Subregion I Sectional Map Amendment be and hereby is amended to include the remainder of Map 5, Grid A-1, Parcel 1, added to that part of the Regional District in Prince George's County, Maryland, by Chapter 624 of the 1990 Laws of Maryland, with zoning designated the same as that portion of Map 5, Grid A-1, Parcel 1, which was already within Subregion I, which amendment is hereby adopted as the comprehensive zoning map for that area and extending thereto the Zoning Ordinance for Prince George's County as amended from time to time.

BE IT FURTHER RESOLVED that the Planning Area Boundary Map for Planning Area 60 be and hereby is amended to include the remainder of Map 5, Grid A-1, Parcel 1, added to that part of the Regional District in Prince George's County, Maryland, by Chapter 624 of the 1990 Laws of Maryland.
