ZONING BILL

AN ORDINANCE concerning

R-E Zone Regulations

For the purpose of modifying the lot width and side yard requirements in the R-E Zone where lot averaging is used or where public water or sewerage systems are utilized.

BY repealing and reenacting with amendments:

Section 27-442, The Zoning Ordinance of Prince George's County, Maryland, being also SUBTITLE 27. ZONING. The Prince George's County Code (1995 Edition). SECTION 1. BE IT ENACTED by the County Council of Prince George's County,

Maryland, sitting as the District Council for that part of the Maryland-Washington Regional District in Prince George's County, Maryland, that Section 27-442 of the Zoning Ordinance of Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code, be and the same is hereby repealed and reenacted with the following amendments:
