**PUBLIC SAFETY & FISCAL MANAGEMENT COMMITTEE REPORT**

Date: 6/4/02

Committee Vote: Favorable, 4-0 (In favor: Councilmembers Wilson, Dernoga, Hendershot and Russell).

This bill contains revisions to the FY 2002 budget and authorizes the appropriation of fund balance in the Drug Enforcement and Education Special Revenue Fund resulting from forfeitures of assets seized by the Police Department or Federal agencies. This revenue will provide matching funds for a Police Department grant program, for costs of targeted law enforcement efforts and specialized equipment. This legislation will not affect the County's General Fund.

The Director of Finance has certified in writing that the fund balance is available for this appropriation.

There should not be any negative fiscal impact on the County as a result of enacting CB-57-2002.

**BACKGROUND INFORMATION/FISCAL IMPACT**

This legislation authorizes the appropriation of fund balance to the Drug Enforcement and Education Special Revenue Fund, resulting from proceeds of forfeitures of assets seized by the Police Department and federal agencies. This revenue will support specialized equipment costs.
