EXPLANATION OF ADJUSTMENTS

Fire Department

The International Association of Fire Chiefs (IAFC) awarded funding totaling \$5,000 to provide funding for Camp Embers; a fire camp to recruit women and underrepresented groups into the fire service. Additional appropriation authority totaling \$5,000 is needed to fully expend the award received.

The Kaiser Foundation Health Plan of the Mid-Atlantic States, Inc. (KFHPMAS) awarded funding totaling \$75,000 for the Kaiser Permanente Mobile Integrated Health Program Enhancement Grant. Funding will improve the wellness and healthcare delivery services to citizens of Prince George's County by extending the Fire Department's reach into the community with paramedicine, telemedicine/telehealth, care coordination and community resource referrals. Additional appropriation authority totaling \$75,000 is needed to fully expend the award received.

The Maryland Department of Health awarded funding for the Firefighters Innovative Screening Technologies Program totaling \$28,823. Funding will provide cancer screening tests for 250 career firefighters and 50 volunteer firefighters. Additional appropriation authority totaling \$28,823 is needed to fully expend the award received.

Department of Corrections

The Governor's Office of Crime Control and Prevention awarded funding totaling \$211,920 to provide residential substance abuse treatment and other re-entry services for inmates upon release back into society.

The Department of Justice Edward Byrne Memorial Justice Assistance Grant awarded funding totaling \$227,127 to provide law enforcement and criminal justice initiatives to help control and prevent crime. Additional appropriation authority totaling \$27,127 is needed to fully expend the award received.

Department of Family Services

The Maryland Department of Aging awarded funding totaling \$68,239 to support the State Health Insurance Program (SHIP). This program provides funding for community based coordinated in-home services to seniors and those with disabilities who may be at risk of nursing home placement. Additional appropriation authority totaling \$1,839 is needed to fully expend the award received.

The Maryland Department of Aging awarded funding totaling \$270,033 for the State Nutrition Homebound Meals grant. This program provides funding for nutrition programs for the elderly. Meals are provided to residents aged 60 and over at locations throughout the County. Additional appropriation authority totaling \$11,833 is needed to fully expend the award received.

The Maryland Department of Aging awarded funding totaling \$598,946 to support the State Nutrition Home Delivered Meals grant. This program provides funding for senior nutrition home delivered meal services to seniors 60 years and older in Prince George's County. Additional appropriation authority totaling \$333,946 is needed to fully expend the award received.

The Center for Workforce Inclusion awarded funding totaling \$506,569 to support the Senior Community Service Training and Employment Program (SCSEP) grant. This program provides funding for low-income older people paid community service and training as an entry to productive work. Additional appropriation authority totaling \$4,269 is needed to fully expend the award received.

The Governor's Office of Crime Control and Prevention awarded funding totaling \$100,000 to help support the Youth Diversion Program grant. This program provides funding for seventy-five youth and their families to address the problems of youth violence and reduce youth involvement with the juvenile justice system.

The Maryland Department of Aging awarded funding totaling \$1,245,301 to support the Senior Care Waitlist grant. This program provides funding for community based coordinated in-home services to seniors and those with disabilities who may be at risk of nursing home placement.

The Maryland Department of Aging awarded funding totaling \$3,726,060 to help support the Older Americans Act and related programming. This program provides funding for health awareness and wellness among Older Americans within the County. Additional appropriation authority totaling \$617,252 is needed to fully expend the award received.

Department of Social Services

The Governor's Office of Crime Control and Prevention awarded funding totaling \$41,280 for the Multidisciplinary Team Facilitator Program. Funding will provide services to improve the collaboration and investigative process between the Multidisciplinary Team (MDT), improved services to child victims and their families that receive services from the child advocacy center (CAC), improve the functioning of the Multidisciplinary Team, training for the facilitator to guide the Multidisciplinary Team and training for members of the Multidisciplinary Team.

Maryland Department of Human Services awarded funding totaling \$35,000 for the Maryland Emergency Food Program (MEFP). Funding will support the purchase of food to be distributed through the soup kitchens, food pantries or facilities that provides food or meals, at no cost, to those in need. Additional appropriation authority totaling \$10,000 is needed to fully expend the award received.

The Department of Justice, Office of Justice Programs in conjunction with the National Children's Alliance has awarded funding totaling \$50,000 for the Military Installation Cooperative Agreement. Funding will support the military's ability to identify, track, monitor and provide services to military affiliated families for all services they are entitled to receive.

Health Department

The Maryland Department of Health awarded \$440,641 for the Babies Born Healthy program. Funding provides perinatal care coordination and navigation services to pregnant individuals who are identified as high-risk for adverse birth outcomes due to medical or social needs. Additional appropriation authority totaling \$200,341 is needed to fully expend the award received.

The District of Columbia Department of Health awarded \$1,291,979 for the Ending the Epidemic Health Resources and Services Administration (HRSA) grant. Funding supports programming to end the HIV epidemic. Additional appropriation authority totaling \$40,079 is needed to fully expend the award received.

The Department of Health and Human Services through the Maryland Department of Health awarded \$404,900 for the Immunization Action program. Funding provides immunization services against childhood diseases to children and young adults. Additional appropriation authority totaling \$172,100 is needed to fully expend the award received and \$20,000 supports the required County match.

The Maryland Department of Health awarded \$680,000 for the Reproductive Health program. This program anticipates the collection of health fees totaling \$85,000. Funding provides health information, education and examinations to children and adults ages twelve and older. Additional appropriation authority totaling \$65,000 is needed to fully expend the award received.

The Department of Health and Human Services through the Maryland Department of Health awarded \$201,565 for the Cities Readiness Initiatives. Funding prepares large geographic and metropolitan areas to respond to bioterrorism attacks and dispense oral antibodies if needed within 48 hours. Additional appropriation authority totaling \$45,765 is needed to fully expend the award received.

The Department of Health and Human Services through the Maryland Department of Health awarded \$636,780 for the Public Health Emergency Preparedness program. Funding provides technical assistance and resources that strengthen public health preparedness and enhance the capabilities of state and local governments to respond to threats. Additional appropriation authority totaling \$99,980 is needed to fully expend the award received.

The Maryland Department of Health awarded \$2,260,573 for the Maryland Children Health Program (MCHP) Eligibility Determination-PWC program. Funding supports the determination of eligibility for medical coverage for qualifying children in Maryland under the age of 19.

Additional appropriation authority totaling \$274,073 is needed to fully expend the award received.

The Maryland Department of Health awarded \$4,284,926 for the General Medical Assistance Transportation services. Funding provides ambulatory and non-emergency wheelchair medical transportation services for recipients who have no other means of transport for medical appointments. Additional appropriation authority totaling \$718,326 is needed to fully expend the award received.

The Maryland Department of Health awarded \$49,994 for the Medicaid Diabetes Prevention project. Funding will support the enrollment of eligible Medicaid participants into the National Prevention Program.

The State of Maryland Attorney General Opioid Fund awarded \$1,283,791 for the Maryland Opioid Restitution Fund. The Opioid Local Abatement Fund is established to receive funds from the state pursuant to settlements or judgments relating to opioids. Funding will be used to build and enhance infrastructures and resources needed to prevent overdoses and substance use-related harms to county residents using evidence-based strategies.

Department of Public Works and Transportation

The Maryland Department of Transportation awarded \$332,819 for the Statewide Specialized Transportation Assistance Program. The funding will support the agency's operating costs. Additional appropriation authority totaling \$19 is needed to fully expend the award received.

The Maryland Energy Administration awarded \$170,000 for the Open Energy Program. The funding will support the biodiesel conversion of six transit buses. Additional appropriation authority totaling \$170,000 is needed to fully expend the award received.

Department of the Environment

The Maryland Department of Agriculture awarded \$32,000 to provide funding for the spay/neuter cats and dog program. This funding will support alterations for approximately 320

cats and dogs. Additional appropriation authority totaling \$6,800 is needed to fully expend the award received.

The Best Friends Animal Society awarded \$4,500 in scholarship funding to support the attendance of animal shelter personnel at the upcoming national conference.

Office of Homeland Security

The Maryland Department of Emergency Management awarded \$278,451 from the Building Resilient Infrastructure and Communities (BRIC)/Hazard Mitigation Program to support the Snow Hill Manor Park Stream Restoration project. This funding will provide flood mitigation benefits by restoring the eroded stream bank and beds and upland areas to reduce stream sediment and erosion problems. A county match of \$69,613 is needed to meet the twenty-five non-federal contribution requirements.

The District of Columbia Homeland Security and Emergency Management Agency awarded funding totaling \$100,000 for the Urban Areas Security Initiative (UASI)- Emergency Response vehicle. Funding will support the purchase of an emergency response vehicle for the Emergency Management Division.

The District of Columbia Homeland Security and Emergency Management Agency awarded funding totaling \$21,000 through the Urban Areas Security Initiative (UASI) for the purchase of specialized software to assist with damage assessments.

Circuit Court

The Maryland Department of Human Services, Child Support Administration awarded funding totaling \$1,080,590 to support the establishment of paternity, and the establishment, modification, enforcement, and recovery of child support payments from non-custodial parents of children. Additional appropriation authority totaling \$140,179 is needed to fully expend the award received.

The Administrative Office of the Courts awarded funding totaling \$252,166 for two courthouse

security goods and service projects \$141,498 and \$110,668, respectively. Funding will support identified courthouse improvement initiatives.
