BACKGROUND INFORMATION/FISCAL IMPACT:

CB-14-2019 amended the definition of Urban Farm in the Zoning Ordinance in accordance with the Zoning Rewrite legislation (CB-13-2018). The definition includes aquaponics. This legislation defines "Aquaponics" in the Zoning Ordinance to provide clarification of this use and also amends the regulations for changes to golf course special exception site plans to include aquaponics.
