Staff provided a summary of the resolution. Referral comments were received. CR-74-2015 expresses approval of the Project and application submitted by Champ House Recovery Inc. to the Maryland Department of Housing and Community Development for Nonprofit Assistance Funds in the amount of \$50,000 for its Roof Renovation Project.

Champ House Recovery Inc. is a non-profit organization that was incorporated in 1990 which provides group home and transition house services to men for the recovery from alcoholism and drug addiction.

Steve Clark, Special Assistant to the Director and Board of Director for Champ House Recovery, Inc. provided testimony in support of the resolution. Similarly, Darryl Robertson Vice President and Board of Director for Champ

House Recovery, Inc. provided testimony in support of the resolution.

The Office of Law provided a written comment that advised that the Office of Law has not located any statutory or regulatory authority requiring a resolution for the submission of applications to the Maryland Department of Housing and Community Development's Nonprofit Assistance Fund.
