**RESOLUTION**

1 A RESOLUTION concerning

2 Maryland – National Capital Park and Planning Commission

3 For the purpose of transferring certain appropriations and expenditures between certain programs  
4 in the FY 2013-14 Operating Budget for the Recreation Fund.

5 WHEREAS, the Annual Budget and Appropriation Ordinance for Fiscal Year 2013-14 for  
6 the Maryland-National Capital Park and Planning Commission was adopted by CB-41-2013; and

7 WHEREAS, under the provisions of the Land Use Article, Section 18-108, the budget may  
8 be amended by resolution by the respective County Councils on their initiative or at the request  
9 of the Commission after receipt of recommendations from the respective County Executives, and  
10 after public hearing upon reasonable notice to the public; and

11 WHEREAS, CB-41-2013 identified funding for a recreation program entitled Suitland Boys and  
12 Girls Club; and

13 WHEREAS, since the adoption of CB-41-2013, the Maryland-National Capital Park and  
14 Planning Commission has identified this program as the Suitland Boys and Girls Club of Greater  
15 Washington; and

16 WHEREAS, the Maryland-National Capital Park and Planning Commission has  
17 determined that, at this time, this program does not meet certain requirements to receive a  
18 Commission subsidy; and

19 WHEREAS, in order to ensure that allocated Recreation funding is utilized in the  
20 appropriate manner, there is a need to decrease funding for the program identified in CB-41-  
21 2013 as the Suitland Boys and Girls Club and to provide funding instead for a recreation  
22 program entitled White Rose Foundation.

1 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
2 County, Maryland, that the following adjustments to the approved Fiscal Year 2013-14  
3 Maryland-National Capital Park and Planning Commission Operating Budget Recreation Fund  
4 programs, as approved in CB-41-2013, are hereby made for the purposes set forth above:
