RESOLUTION

A RESOLUTION concerning

Maryland - National Capital Park and Planning Commission

For the purpose of transferring certain appropriations and expenditures between certain programs in the FY 2013-14 Operating Budget for the Recreation Fund.

WHEREAS, the Annual Budget and Appropriation Ordinance for Fiscal Year 2013-14 for the Maryland-National Capital Park and Planning Commission was adopted by CB-41-2013; and

WHEREAS, under the provisions of the Land Use Article, Section 18-108, the budget may be amended by resolution by the respective County Councils on their initiative or at the request of the Commission after receipt of recommendations from the respective County Executives, and after public hearing upon reasonable notice to the public; and

WHEREAS, CB-41-2013 identified funding for a recreation program entitled Suitland Boys and Girls Club; and

WHEREAS, since the adoption of CB-41-2013, the Maryland-National Capital Park and Planning Commission has identified this program as the Suitland Boys and Girls Club of Greater Washington; and

WHEREAS, the Maryland-National Capital Park and Planning Commission has determined that, at this time, this program does not meet certain requirements to receive a Commission subsidy; and

WHEREAS, in order to ensure that allocated Recreation funding is utilized in the appropriate manner, there is a need to decrease funding for the program identified in CB-41-2013 as the Suitland Boys and Girls Club and to provide funding instead for a recreation program entitled White Rose Foundation.
