### **Transporation, Housing & Environment Committee**

The Transportation Housing and Environment Committee (THE) met on April 5, 2006 to consider CR-19-2006. CR-19-2006 is in follow up to CB-41-2005, the towing legislation that was enacted last year. CR-19-2006 establishes a towing task force to review and evaluate the County's towing regulations and their impact on the County residents, agencies and the industry and recommend appropriate amendments to towing regulations. The Office of Law found CR-19-2006 to be proper legislative form; the Council's Legislative Officers have also concurred with the Office of Law, however they suggested amending the date on page 2, line 11 from May 26, 2006 to A date in September. The Office of Audits & Investigations indicated that there will not be any adverse impact on the County as a result of adopting CR-19-2006. The sponsor of CR-19-2006, Councilwoman Exum did amend the date to September 28, 2006 to allow the task force adequate time to review and evaluate the towing regulations and present its recommendations to the Council that will be reflected in Draft 2.
