**REPORT:** Favorable 5-0: Council Members Burroughs, Oriadha, Fisher, Harrison, and Ivey.

The Government Operations and Fiscal Policy Committee met on June 22, 2023, to consider APPT-19-23, the County Executive's nominees to the Personnel Board. The Personnel Board plays a vital role in interpreting and adjudicating Personnel law, County regulations, and administrative policies, all of which are critical to the proper and efficient operation of County government.

Ms. Miriam Brewer, Appointment Liaison, Office of the County Executive, provided an overview of the qualifications of the reappointees to the Personnel Board for Prince George's County: Ms. Delores M. Stuckey, Ms. Yvonne V. Hefley, Ms. Darlene M. Neal, and Mr. Ike B. Udejiofor, Ph.D., after which the nominees provided information on their background and their desire to serve on the Personnel Board.

Ms. Stuckey, a resident of Bowie, did not participate in the committee meeting due to attending a family member's funeral. She is Chief of the Learning and Development Division at the Pension Benefit Guaranty Corporation. Ms. Stuckey is a graduate of Howard University with a Bachelor of Science degree in Psychology and George Washington University with a Master of Arts degree in Education and Human Development. Ms. Stuckey will continue to serve as Chair of the Personnel Board.

Ms. Hefley, a resident of Oxon Hill, retired from the federal government after thirty (30) years of service. She serves as a Mediator for the Prince George's County

Community Mediation Program, the District Court of Maryland (small claims cases), and the Montgomery County Circuit Court.

Ms. Neal, a resident of Temple Hills, is an experienced Human Resources Management professional. She has over two decades of experience in policy writing, retirement consultation, claims examination/adjudication, merit staffing position classification, and performance management. She received her Bachelor of Science degree in Business Administration from Strayer University.

Mr. Udejiofor, a resident of Glenn Dale, has over twenty-five (25) years of well-rounded experience in governmental human resources. He is the Senior Human Resources Specialist with the United States Office of Personnel Management. Mr. Udejiofor obtained two undergraduate degrees from the University of Iowa: a Master's in Public Administration from the University of Nebraska at Omaha and a Doctorate in Public Administration from Howard University.

After discussion, the Government Operation Fiscal Policy Committee voted the nominees to the Personnel Board out favorably, 5-0.
