**BACKGROUND INFORMATION/FISCAL IMPACT:**

This Resolution amends the County “Annual Action Plan: FY 2006,” “Annual Action Plan: FY 2007,” and “Annual Action Plan: FY 2008” to allow World Arts Focus, Inc. to be reimbursed for eligible pre-award costs of \$83,052.13 in FY 2006 and \$289,029.10 in FY 2007 associated with the “World Arts Focus Building a Performance Theater FY 08” project; reducing the FY 2008 CDBG award from \$642,247 to \$270,192.77. This legislation requires a minimum of one public hearing pursuant to “County Citizen Participation Plan FY: 2006-2010,” as amended by CR-81-2005.
