Good Morning Council Member Olson and Ms. Brooks,

Please take note of the following update:

The Quality Assurance Officer of the enforcement department investigated Princess Garden Parkway and the 9300 block of 4th Street in Lanham, Maryland. The officer only found six immediate violations that required citation issuance during the patrol. Moreover, the officer observed no wrecked or dismantled vehicles at the addresses mentioned in the initial email. You can find the attached photo evidence for your reference.

Additionally, an officer from the Abandoned Vehicle Unit addressed the service request for investigation of the boat/trailer on Princess Garden Parkway. The vehicle was tagged as inoperable and will be scheduled for removal if the owner fails to comply within a specific timeframe.

I understand the boat is causing an inconvenience and is unsightly on the roadway. I appreciate your patience while I worked directly with another department manager to resolve this issue promptly.

We will continue to monitor and cite any violations accordingly. However, if any immediate concerns require my direct attention, please do not hesitate to bring them to my attention.

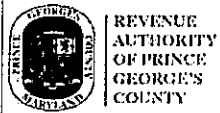

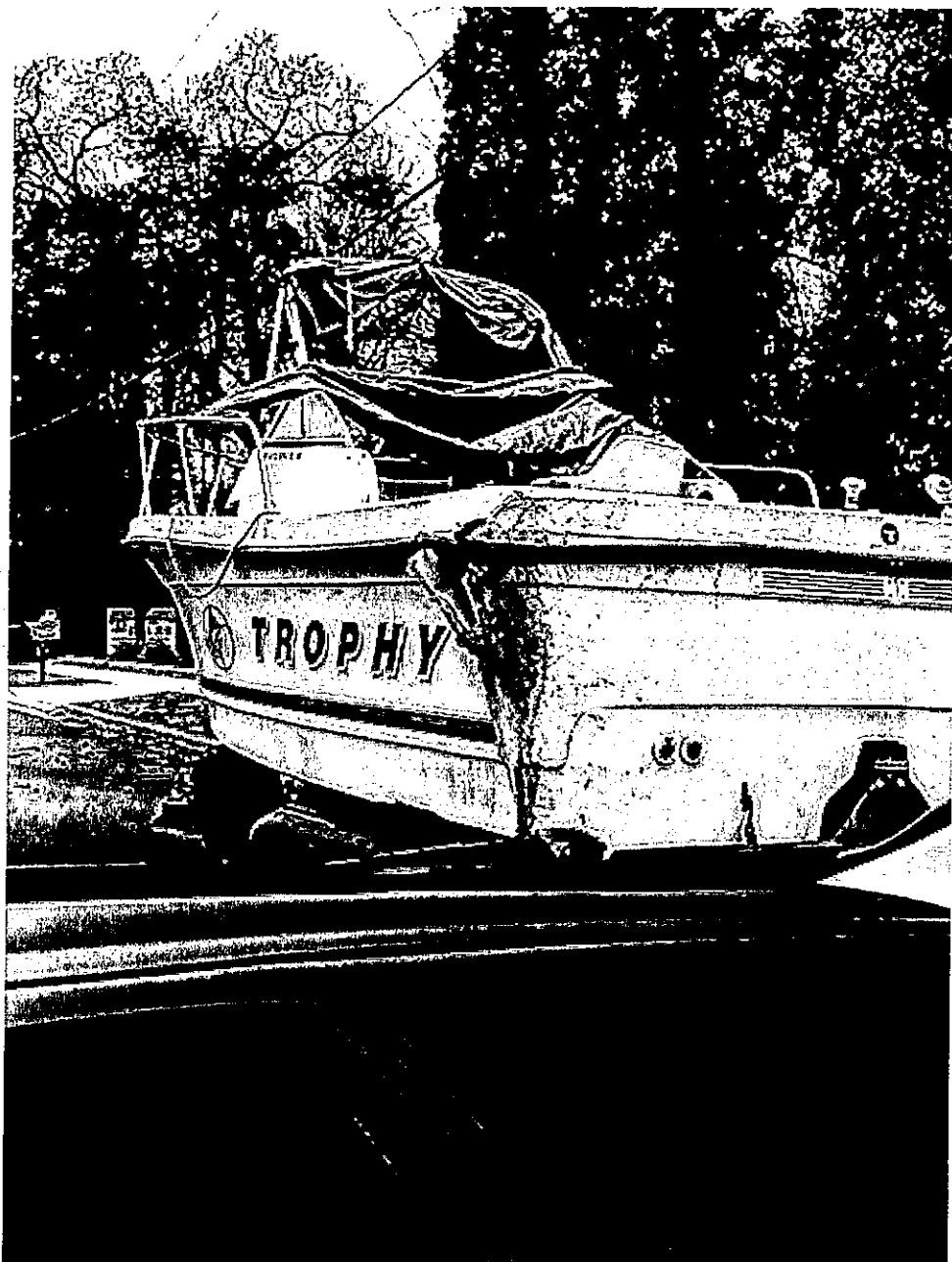
