BRIEFING ON THE STATUS OF THE HEAD START PROGRAM AND STUDENT SAFETY

Chairman Davis opened the meeting with a brief statement outlining the the purpose for this briefing before the Committee of the Whole with emphasis on the safety of every student within the Prince George's County Public School System. Dr. Maxwell addressed the Council by first outlining the positive positive strides made by the school system and spoke to the decision to start the program on time, despite the loss of funding. He explained his disciplinary actions thus far and and thanked the Council for providing additional funding for reporting and investigation of issues and training for employees. Dr. Segun Eubanks, Board Chair, spoke to the board's efforts on this issue.

The panel responded to questions posed by the Council regarding: mandatory reporting, disciplinary actions, regaining trust, the private provider, day to day operations, screening and supervision, task force recommendations, the process for termination of certificated employees versus non-certificated employees, public policies for Head Start and general governance, increases in reporting, collaboration with Child Protective Services, transparency with parents and the community, leadership "steadiness", school culture, the interworking of the Head Start program, responsibility of the Parent Counsel, Board oversight of the Parent Counsel, timeline of reporting and policy changes in certain published cases, student safety, consequences for the inaction of the board, and timelines for investigations and restoration of cleared employees. Chairman Davis clarified the roles of the County Council, the Board of Education, the County Executive and the School System Administration. He allowed the Council's representative on the Board, Curtis Valentine, to speak to his role.
