



















# **Program Overview**

- Established by CB-4-2011
- Allows Prince George's County to support development opportunities and job retention and job attraction by providing critically needed financial assistance to projects that "but for" this public/private partnership will not occur and where market forces do not create the incentive to sustain private investments.
- Fund should be used strategically to support developed tier and gateway communities, TOD, and local minority and small businesses, among other critical priorities.
- Fund established as non-lapsing.
- CB-78-2013 amended the fund to provide special consideration for local entrepreneurs that were also County residents

# Program Purpose

- ► Sec. 10-284.(a) Purpose ad uses.
  - Assist in retention of existing industry and commerce in the County and in the attraction of new industry and commerce to the County
  - Create new jobs and retain existing jobs for County residents
  - Broaden the local tax base, particularly the commercial tax base
  - Promote economic development and the growth of the Prince George's County economy, with a special strategic focus on the developed tier and gateway communities that have suffered from a lack of investment and economic development and those areas where market dynamics do not create sufficient economic incentives to sustain private sector development
  - Promote local, minority, and small businesses in the County
  - ► Encourage TOD development, a balanced economy and international resources and trade to promote job growth, business attraction & retention for County businesses and residents

# Program Use

- ► Sec. 10-284.(b) Financial Assistance.
  - ► The Fund may provide financial assistance in the form of loans, guarantees, conditional loans and grants for the benefit of existing and potential industrial and commercial businesses in Prince George's County
  - ► Fund may be used to leverage funding as in for equity investments, and to participate with other government agencies or private sector institutions to leverage funding for special projects

# How the Fund Works

- Section 10-286. Administration of the Fund
  - ► CAO administers the Fund, or their designee
  - ► FSC is designee for intake, application review, underwriting and portfolio management
  - ▶ EDC is designee for marketing, intake, and application review
  - Financial Advisory Committee (FAC) aids in the review of and provide credit guidance regarding financial assistance applications (County Council & Administration selects members)

# The Application Process

- Section 10-287. Financial assistance application and approval
- Applicant applies in writing via formal application submitted to EDC and occasionally FSC
- EDC Application reviewed for fund eligibility
- EDI Review Team (FSC, EDC, OOL, and Procurement) reviews application to concur on project viability, eligibility and compliance requirements
- ► EDC issues a Letter of Intent with specified terms of potential funding contingent upon underwriting
- FSC underwrites the application
- FSC presents the loan request to FAC. FAC approves or denies request.

# The Application Process Cont'd

- Section 10-287. Financial assistance application and approval
- ▶ If approved, EDC prepares a letter to request concurrence from the CAO.
- ► If CAO approves, EDC prepares Notice of Intent to County Council for concurrence (Loans under \$250,000 = Council acknowledgement; loans greater than \$250,000 = Council approval
- Notice of Intent letter sent to Council Administrators. 7 calendar days to provide written comments or notice of objection
- Council administrators determine necessity of outside review by Council consultant and obtains Council concurrence
- Office of Law drafts loan commitment letter

# The Application Process Cont'd

- Section 10-287. Financial assistance application and approval
- Council administrators facilitate drafting of Council concurrence letter and submits to EDC
- ► EDC notifies FSC and Law Office of concurrence letter
- ► Law Office draft loan documents based on FSC approved loan narrative
- ► FSC schedules and conducts loan settlement and submits loan disbursement request to Office of Finance
- Office of Finance wires the funds
- ► FSC provides portfolio & asset management and compliance for the life of the loan
