| was adopted by t | he County Council on September 25, 2018 with the passage of CR-52-2018; and |
| WHEREAS | S, the Salary Plan needs to be amended to reflect the terms of the recent |
| agreement by an | d between Prince George's County, Maryland and the International Association |

of Fire Fighters, AFL-CIO, Local 1619 (Fire Fighters, Paramedics, and Fire Fighter/Medics).

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's

| 1 | County, Maryland, that an amendment to Salary Schedule Y submitted and recommended by the |

| 2 | County Executive on April 29, 2020, as set forth below that modifies Section 8, Pay in Excess of |
| 3 | Base Salary, be and the same is hereby approved: |
| 4 | Add New Paragraph L to Section 8 of Salary Schedule Y, which shall read as follows: |
| 5 | L. As we continue to address the COVID-19 pandemic, employees covered by Salary |
| 6 | Schedule Y are entitled to receive a stipend in the amount of \$350.00 per pay period. The |
| 7 | stipend will be called the COVID-19 Hazard Pay. For an employee to receive the COVID- |
| 8 | 19 Hazard Pay, an employee must work 75% of their scheduled hours. If an employee |
| 9 | works less than 75% of their scheduled hours, the COVID-19 Hazard Pay shall be prorated |
| 10 | accordingly. The COVID-19 Hazard Pay will start with the pay period beginning April 5, |
| 11 | 2020, and continue until the County declaration of emergency is terminated, or June 28, |
| 12 | 2020, whichever is earlier. |
| 13 | BE IT FURTHER RESOLVED that this Resolution shall take effect on the day it is |
| 14 | adopted and shall be retroactively effective to April 5, 2020. |
