Dear Chair Burroughs:

It is my pleasure to submit to you and the County Council the appointment of Acting Chief George Nader as the Chief of Police for the Prince George's County Police Department.

Chief Nader brings more than thirty-one years of exemplary law enforcement experience, including over eighteen years in executive command positions. His career spans a range of leadership responsibilities within the Prince George's County Police Department and the Metro Transit Police Department, reflecting a demonstrated commitment to public safety, institutional reform, and strategic innovation. He has led major bureaus, overseen critical homeland security operations, managed multimillion-dollar budgets and capital projects, and developed cross-jurisdictional initiatives that have enhanced safety across the region.

Chief Nader's career reflects an impressive breadth of subject matter expertise, including leadership and organizational management, human resource development, emergency preparedness, homeland security, budgeting, criminal and internal investigations, and intelligence operations. He has played key roles in legislative affairs and policy development, crime analysis, infrastructure protection, and media relations. In addition to designing and implementing several forward-looking policing programs, including crisis intervention initiatives, civil disturbance training, and community-based engagement models, he has served as a liaison to federal agencies and maintained critical national security partnerships.

A highly decorated officer, Chief Nader has received a Special Congressional Recognition, the Silver Medal of Valor, three Chief's Awards, two Unit Citations, the Commander's Award, seven Good Conduct Awards, the Baltimore Unrest Ribbon, six Certificates of Accomplishment, and more than forty Letters of Commendation. He has served as chair and voting member on various quasi-judicial and administrative boards, including the Prince George's County Nuisance Abatement Board and multiple Administrative Hearing Boards.

Importantly, Chief Nader is a proud product of Prince George's County, raised in our communities, shaped by our values, and committed to our future. His return to serve and lead as

Chief of Police is more than a professional appointment; it is a homecoming. Today, we welcome him back to lead the women and men of our Police Department and to serve the residents of the county he has always called home.

Throughout his career, Chief Nader has demonstrated a steadfast commitment to excellence, transparency, and accountability. His leadership has fostered trust between law enforcement and the communities they serve. His work is deeply rooted in a belief in the power of collaboration, equity, and ethical service, and his vision for the future of policing in Prince George's County aligns with our broader goals of public trust, safety, and reform.

Pursuant to Sections 322, 402, and 504 of the Charter of Prince George's County, I am appointing Acting Chief George Nader as the Chief of Police for the Prince George's County Police Department. Attached for the Council's consideration are Chief Nader's resume and Appointee Data Form. A copy will be provided to the Prince George's County Office of Ethics upon confirmation.
