BILL

1 AN ACT concerning

2 The Classification Plan for Prince George’s County

3 For the purpose of amending certain class titles and grades, adding new classes of work and
4 abolishing certain classes of work.

5 WHEREAS, the County Executive, pursuant to Section 903 of the Prince George’s County
6 Charter and Section 16-125(a) of Subtitle 16 of the Prince George’s County Code, has, in order
7 to provide better governmental services, recommended to the County Council amendments to the
8 Classification Plan for Prince George’s County with respect to amending class titles and grades,
9 adding and abolishing certain classes of work described within Section 1 of this Bill; now,
10 therefore,

11 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
12 Maryland, that the Classification Plan for Prince George’s County be and the same is hereby

19 SECTION 2. BE IT FURTHER ENACTED that the provisions of this Act are hereby
20 declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph,
21 sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of
22 competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining
23 words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this
24 Act, since the same would have been enacted without the incorporation in this Act of any such
25 invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph, subsection,
26 or section.

27 SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)
28 calendar days after it becomes law.
