It is my pleasure to submit to you and the County Council the appointment of Ms. Stephanye R. Maxwell, Esq., CPM to the Prince George's County Police Accountability Board (PAB).

Ms. Stephanye R. Maxwell, a resident of Laurel, is a Certified Public Manager and a recent retiree from Prince George's County Government. She served as the Seventh Judicial Circuit Court's Administrator. Major accomplishments included coordinating statewide efforts to automate day-to-day operations of the Court (virtual trials and hearings, online pleadings, motions, and jury selection); establishing two non-profit entities for the Court's Family Justice Center and Problem-Solving Courts; and the implementation of a Continuity of Operations Plan (COOP) to address the pandemic to ensure critical services remained operational. Ms. Maxwell previously served as Director, Office of Human Resources Management; Legal Counsel for the Office of Personnel and Labor Relations; and as Associate County Attorney within the Office of Law. She is a visionary, results-oriented professional with a proven track record of skillful management of human capital.

Ms. Maxwell received her undergraduate degree from Boston College and her Doctor of Jurisprudence from Catholic University of America, Columbus School of Law. She possesses a Certified Public Manager (CPM) designation from George Washington University Center for Excellence in Municipal Management and maintains professional affiliations with the State of Maryland Bar, United States Federal District Court Bar, and the United State Supreme Court Bar.
