**BILL**

1 AN ACT concerning

2 Human Relations Commission

3 For the purpose of amending the provisions of the County Code relating to the Executive  
4 Director, staff, and budget of the Human Relations Commission.

5 BY repealing and reenacting with amendments:

6 SUBTITLE 2. ADMINISTRATION.

7 Section 2-190,

8 The Prince George's County Code

9 (2007 Edition, 2010 Supplement).

10 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
11 Maryland, that Section 2-190 of the Prince George's County Code be and the same is hereby  
12 repealed and reenacted with the following amendments:

13 SUBTITLE 2. ADMINISTRATION.

14 DIVISION 12. HUMAN RELATIONS COMMISSION.

15 SUBDIVISION 2. ADMINISTRATIVE PROVISIONS.

16 **Sec. 2-190. Executive Director; budget.**

17 (a) The County Executive shall appoint an Executive Director. He shall supervise the  
18 operations of the administrative staff and shall perform such other duties as are prescribed by the  
19 Commission [, including the hiring, direction and discharge of all Commission staff members in  
20 accordance with the County personnel laws. The Director and his staff shall be compensated as  
21 provided in the classification plan of the County].

1 (b) The proposed budget of the Commission shall be submitted to the County Executive as  
2 part of the budget of the Office of Community Relations in accordance with County budget  
3 procedures. [funded as a separate budget entity in the Annual Budget and Appropriation  
4 Ordinance.] Subject to the provisions of Article VIII of the Charter, it is authorized to expend  
5 funds derived from private grants, the State or the United States to carry out its functions and  
6 activities, and to cooperate with any agency of the State or the United States in carrying out its  
7 functions and activities.

8 SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)  
9 calendar days after it becomes law.
