REPORT: COMMITTEE VOTE: Favorable 3-0 (Councilmember's: Campos, Davis, and Lehman)

This bill will amend Section 9 of the Schedule of Legislation by changing the name of the Office of Information Technology and Communications to the Office of Information Technology. This name change will more accurately reflect the functions of this Office.

Pursuant to Section 503 of the County Charter, this proposed change will become effective on November 5, 2012 unless disapproved by a majority vote of the full Council prior to that date.

The Office of Law has reviewed this bill and finds it to be in proper legislative form with no legal impediments to its enactment.

The enactment of CB-70-2012 will have a minimal adverse fiscal impact on the County related to the cost of new office supplies to reflect the name change.
