WHEREAS	, Sections 104(b)(2) and 106(d)(5) of the Housing and Community	
Development Ac	t of 1974, as amended, specifically require Community Development Block	
Grant (CDBG) P	rogram grantees to certify to "affirmatively further fair housing choice."	
Furthermore, Con	ngress reiterated this obligation in Section 105(b)(13) of the National Affordable	
Housing Act of 1	990; and	
WHEREAS, it is appropriate for the County to update and submit the Analysis of		
Impediments to Fair Housing Choice at least once every 5 years, consistent with the		
Consolidated Pla	n cycle; and	
WHEREAS, Mullin & Lonergan Associates, Inc. was retained as a reputable firm to		
conduct the Analysis of Impediments to Fair Housing Choice; and		
WHEREAS	, the Analysis of Impediments to Fair Housing Choice is a review of a	
jurisdiction's laws, regulations, and administrative policies, procedures, and practices affecting		
the location, availability, and accessibility of housing, as well as an assessment of conditions,		
both public and p	rivate, affecting fair housing choice; and	
WHEREAS	, the U. S. Department of Housing and Urban Development (HUD) defines an	
impediment to fair housing planning choice as any actions, omissions, or decisions that restrict,		

or have the effect of restricting, the availability of housing choices, based on race, color, religion,

sex, disability, familial status, or national origin; and

WHEREAS, persons residing in Maryland have greater protection under the Maryland Human Relations Act than under the Federal Fair Housing Act, which incorporates marital status and sexual orientation as part of housing discrimination; and

WHEREAS, Section 2-185 of the Prince George's County Code establishes the Human Relation Commission; more importantly, Section 2-185 extends protection from discrimination to include age, occupation, political opinion, and personal appearance; and

WHEREAS, The Analysis of Impediments to Fair Housing Choice evaluated population, household, income and housing characteristics by protected classes; evaluated public and private sector policies that impact fair housing choice; identified blatant or de facto impediments to the fair housing choice, where any may have existed; and recommended specific strategies to overcome the effects of any identified impediments; and

WHEREAS, in order to continue to alleviate and eliminate the identified impediments within Prince George's County, a Fair Housing Action Plan was developed and will be reported in the County's Consolidated Annual Performance and Evaluation Report (CAPER) each program year.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the "Analysis of Impediments to Fair Housing Choice," a copy of which shall be marked for identification by the Clerk of the County Council and maintained as a permanent record, is hereby approved, in accordance with the draft Analysis of Impediments to Fair Housing Choice, Attachment "A", attached hereto and made a part hereof.

BE IT FURTHER RESOLVED that the County Executive or his designee is hereby authorized and empowered as the official representative of Prince George's County to submit the approved "Analysis of Impediments to Fair Housing Choice" to HUD, along with all assurances contained therein, to act as necessary in connection with the submission, and to provide such additional information to HUD as may be required.

BE IT FURTHER RESOLVED that this resolution shall become effective as of the date of its adoption.
