This Resolution will provide supplemental appropriations of Federal and State funds in the amount of \$4,615,713 for FY 2011. The supplemental grant funding will support new and/or continuing grant program efforts for the following four (4) County agencies:

1. Department of Family Services.....\$1,041,532

(Provide services to juveniles at risk of out-of-home placement, Shelter Plus Care Program and offer low income seniors paid community service and training)

2. Health Department......\$115,000

(Support the response efforts to the H1N1 virus)

3. Office of the State's Attorney.....\$500

Fire/EMS Department.....\$3,458,681 (Provide funding directly to the Department to increase the number of trained "first line" firefighters in their communities.) Total......\$4,615,713 The Office of Law has reviewed this resolution and finds it to be in proper legislative form with no legal impediments to its adoption. This resolution was amended on page 5 under the Fire/EMS Department by deleting the last sentence which states "This adjustment is provided through the American Recovery and Reinvestment Act of 2009". The grant appropriations reflect \$3,961,052 in direct Federal allocations and \$654,66l in State allocations. There are no County funds appropriated. The adoption of CR-86-2010 will not have a negative fiscal impact on the County. **BACKGROUND INFORMATION/FISCAL IMPACT:** (Includes reason for proposal, as well as any unique statutory requirements) This resolution will provide for Supplementary Appropriations to grant programs in Fiscal Year 2011. The adjustments to appropriations total \$4,615,713 and will support the programmatic operations of four agencies.
