ZONING BILL

1 AN ORDINANCE concerning

2 Cannabis Uses

3 For the purpose of adding definitions and designating areas for Cannabis uses consistent with
 4 authority set forth in State law; prohibiting On-site cannabis consumption uses; setting forth
 5 regulations for permitted Cannabis uses; providing for the prospective application of provisions
 6 and amendments adopted herein; and providing a severability clause for the provisions related to
 7 Cannabis uses in Prince George's County.

8 BY repealing and reenacting with amendments:

9 Sections 27-11001, 27-2500, 27-5101, 27-5102, and 27-5402,

10 The Zoning Ordinance of Prince George's County, Maryland,

12 SUBTITLE 27. ZONING.

13 The Prince George's County Code

14 (2019 Edition; 2022 Supplement).

15 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
 16 Maryland, sitting as the District Council for that part of the Maryland-Washington Regional
 17 District in Prince George's County, Maryland, that Sections 27-11001, 27-2500, 27-5101,
 18 27-5102, and 27-5402 of the Zoning Ordinance of Prince George's County, Maryland, being also
 19 Subtitle 27 of the Prince George's County Code, be and the same are hereby repealed and

reenacted with the following amendments:

SUBTITLE 27. ZONING.

PART 27-1. GENERAL PROVISIONS.

SECTION 27- 11000. REGULATIONS APPLICABLE IN ALL ZONES.

Sec. 27-11001. Prohibited Uses.

(a) The following uses are prohibited in all zones:

(1) The display or sale of drug paraphernalia.

(A) "Drug Paraphernalia" means all equipment, products, and materials of any kind which, in violation of Title 5, Criminal Law Article, Annotated Code of Maryland, are used in:

(i) planting, propagating, cultivating, growing, harvesting, manufacturing, compounding, converting, producing, processing, preparing, testing, analyzing, packaging, repackaging, storing, containing, or concealing a controlled dangerous substance; or

(ii) injecting, ingesting, inhaling, or otherwise introducing into the human body a controlled dangerous substance [in violation of Subheading Health-Controlled Dangerous Substances, Article 27, Annotated Code of Maryland. "Drug Paraphernalia" includes:]

[i. Kits used in planting, propagating, cultivating, growing, or harvesting of any species of plant which is a controlled dangerous substance or from which a controlled dangerous substance can be derived];

[ii. Kits used in manufacturing, compounding, converting, producing, processing, or preparing controlled dangerous substances;]

[iii. Isomerization devices used in increasing the potency of any species of plant which is a controlled dangerous substance;]

[iv. Testing equipment used in identifying or analyzing the strength, effectiveness, or purity of controlled dangerous substances;]

[v. Scales and balances used in weighing or measuring controlled dangerous substances;]

[vi. Dilutants and adulterants, such as quinine hydrochloride, mannitol, mannite, dextrose, and lactose, used in cutting controlled dangerous substances;]

[vii. Separation gins and sifters used in cleaning or refining marijuana;]

[viii. Blenders, bowls, containers, spoons, and mixing devices used in

1 compounding controlled dangerous substances;]

2 [ix.Capsules, balloons, envelopes, and other containers used in packaging
3 small quantities of controlled dangerous substances;]

4 [x.Containers and other objects used in storing or concealing controlled
5 dangerous substances;]

6 [xi.Hypodermic syringes, needles, and other objects used in parenterally
7 injecting controlled dangerous substances into the human body;]

8 [xii.Objects used for ingesting, inhaling, or otherwise introducing marijuana,
9 cocaine, hashish, or hashish oil into the human body, such as:]

10 [(aa) Metal, wooden, acrylic, glass, stone, plastic, or ceramic pipes,
11 with or without screens, permanent screens, hashish heads, or punctured metal bowls;]

12 [(bb) Water pipes;]

13 [(cc) Carburetion tubes and devices;]

14 [(dd) Smoking and carburetion masks;]

15 [(ee) Roach clips (meaning objects used to hold burning material, such
16 as a marijuana cigarette, that has become too small or too short to be held in the hand);]

17 [(ff) Miniature cocaine spoons and cocaine vials;]

18 [(gg) Chamber pipes;]

19 [(hh) Carburetor pipes;]

20 [(ii) Electric pipes;]

21 [(jj) Air-driven pipes;]

22 [(kk) Chilams;]

23 [(ll) Bongs; and]

24 [(mm) Ice pipes or chillers.]

25 **(B)** In determining whether an object is drug paraphernalia, a court or other
26 authority shall consider, in addition to all other logically relevant factors, the [following:]-factors
27 in Title 5, Criminal Law Article, Annotated Code of Maryland.

28 [(i) Statements by an owner or by anyone in control of the object
29 concerning its use;]

30 [(ii) Prior convictions (if any) of an owner or anyone in control of the
31 object, under any State or Federal law relating to any controlled dangerous substance;]

[(iii) The proximity of the object, in time and space, to a direct violation of Subheading Health-Controlled Dangerous Substances, Article 27, Annotated Code of Maryland;]

[(iv) The proximity of the object to controlled dangerous substances;]

[(v) The existence of any residue of controlled dangerous substances on the object;]

[(vi) Direct or circumstantial evidence of the intent of an owner, or of anyone in control of the object, to deliver it to persons whom he knows, or should reasonably know, intend to use the object to facilitate a violation of Subheading Health-Controlled Dangerous Substances, Article 27, Annotated Code of Maryland. The innocence of an owner, or of anyone in control of the object, as to a direct violation of that Subheading shall not prevent a finding that the object is used as drug paraphernalia;]

[(vii) Instructions, oral or written, provided with the object concerning its use;]

[(viii) Descriptive materials accompanying the object which explain or depict its use;]

[(ix) National and local advertising concerning its use;]

[(x) The manner in which the object is displayed for sale;]

[(xi) Whether the owner, or anyone in control of the object, is a legitimate supplier of similar or related items to the community, such as a licensed distributor or dealer of tobacco products;]

[(xii) Direct or circumstantial evidence of the ratio of sales of the object to the total sales of the business enterprise;]

[(xiii) The existence and scope of legitimate uses for the object in the community; or]

[(xiv) Expert testimony concerning its use.]

(C) The definitions contained in [Article 27, Section 277, Annotated Code of Maryland] Title 5, Criminal Law Article, Annotated Code of Maryland, are a part of this Section to the same extent as if they were fully described in the Section.

PART 27-2. INTERPRETATION AND DEFINITIONS.

SECTION 27-2500. DEFINITIONS.

[Medical cannabis] Cannabis

[Any product containing usable cannabis or usable medical cannabis finished product.]

(a)The plant *Cannabis Sativa* L. and any part of the plant, including all derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether growing or not, with a Delta-9-TetraHydrocannabinol concentration of greater than 0.3% on a dry weight basis.

(b)“Cannabis” includes Cannabis products.

(C)“Cannabis” does not include “hemp “ or “hemp products,” as defined in Agriculture Article, Annotated Code of Maryland.

[Medical cannabis dispensary] Cannabis dispensary

[An entity licensed under Subtitle 33 of the Health – General Article, Annotated Code of Maryland, that acquires, possesses, repackages, processes, transfers, transports, sells, distributes, or dispenses products containing usable medical cannabis, related supplies, or related products, including tinctures, aerosols, oils, or ointments; or provides educational materials for use by a qualifying patient or caregiver.]

A use which entails acquiring, possessing, repackaging, transferring, selling, distributing, or dispensing Cannabis or Cannabis products, including tinctures, aerosols, oils, and ointments, related supplies, and educational materials for use by a qualifying patient, caregiver, or adult over the age of 21 through a storefront. Cannabis dispensary also includes a former medical cannabis dispensary that converted its license to allow for the sale of both medical and adult use cannabis pursuant to Alcoholic Beverages & Cannabis Article, Annotated Code of Maryland.

[Medical cannabis finished product] Cannabis finished product

A product containing a [medical] cannabis concentrate or a [medical] cannabis-infused product packaged and labeled for release to a qualifying patient , caregiver, or adult over the age of 21.

[Medical cannabis grower and/or processor] Cannabis grower

[A medical cannabis grower is an entity licensed under Subtitle 33 of the Health – General Article, Annotated Code of Maryland, that cultivates, manufactures, packages, processes, or

1 distributes medical cannabis to licensed processors, licensed dispensaries, or registered
 2 independent testing laboratories. A medical cannabis processor is an entity licensed under
 3 Subtitle 33 of the Health – General Article, Annotated Code of Maryland, that transforms
 4 medical cannabis into another product or extract, and packages and labels medical cannabis.]

5 A use that entails cultivating or packaging cannabis, as well as providing cannabis to other
 6 Cannabis uses and registered independent testing laboratories. Cannabis grower also includes a
 7 former medical cannabis grower that converted its license to allow for the growing of Cannabis
 8 for medical and adult use pursuant to the Alcoholic Beverages & Cannabis Article, Annotated
 9 Code of Maryland.

10 * * * * *

11 **Cannabis incubator**

12 An entity licensed under the Alcoholic Beverages & Cannabis Article, Annotated Code of
 13 Maryland, to operate a facility within which Cannabis micro-dispensaries; Cannabis micro-
 14 growers; and/or Cannabis processors may operate.

15 **Cannabis micro-dispensary**

16 A use that entails acquiring, possessing, repackaging, transferring, selling, distributing, or
 17 dispensing Cannabis or Cannabis products, including tinctures, aerosols, oils, and ointments,
 18 related supplies, and educational materials for use by a qualifying patient, caregiver, or adult
 19 over the age of 21 solely through a delivery service or transport. Cannabis micro-dispensary is
 20 limited to ten (10) employees and may not have a physical storefront.

21 **Cannabis micro-grower**

22 A use that entails cultivating or packaging no more than 10,000 square feet of indoor
 23 cannabis canopy or 40,000 square feet of outdoor cannabis canopy, as well as providing cannabis
 24 to other Cannabis uses and registered independent testing laboratories.

25 **Cannabis micro-processor**

26 A use that entails transforming no more than 1,000 pounds of Cannabis per year into
 27 another product or extract, packaging and labeling the Cannabis product, and providing Cannabis
 28 to other Cannabis uses and registered independent testing laboratories.

29 **Cannabis on-site consumption establishment**

30 A use that entails distributing Cannabis or Cannabis products for on-site consumption other
 31 than consumption by smoking indoors.

Cannabis Processor

a use that entails transforming Cannabis into another product or extract, Packaging and labeling the cannabis product, and providing Cannabis to other Cannabis uses and registered independent testing laboratories. Cannabis processor also includes a former Medical cannabis processor that converted its license to allow for the processing of Cannabis for medical and adult use pursuant to Alcoholic Beverages & Cannabis Article, Annotated Code of Maryland.

(B) [Medical Cannabis Grower and/or Processor] Cannabis Grower

(i) The boundaries of property used for [medical] cannabis grower [and/or processor] uses shall be located a minimum of 300 feet from:

a. Any [of the following zones: AR, RE, RR, RSF-95, RSF-65, and R-PD] residential zone, including a residential comprehensive design zone under the prior ordinance;

b. [Any land owned by The Maryland-National Capital Park and Planning Commission] a playground, recreation center, library, or public park; and

c. Any [use in the Educational Uses Principal Use Category] pre-existing primary or secondary school in the State, or a pre-existing licensed childcare center or registered, pre-existing family childcare home under the Education Article, Annotated Code of Maryland.

(ii) Buildings, structures, and parking shall be located the following minimum distance from property lines:

a. In the AG zone: 200 feet; and

b. In the IE zone: 50 feet.

(iii) In the AG zone, the minimum net lot area is 10 acres.

(iv) Except for outdoor cultivation in the AG Zone pursuant to State licensing regulations, all aspects of the use shall be conducted within a fully enclosed building, in accordance with all applicable laws, rules, and regulations.

(v) In the AG Zone, outdoor cultivation areas shall be located a minimum of 100 feet from any street or property line and shall be fenced in accordance with applicable State licensing regulations. A planted bufferyard between the fence line and cultivation area shall be installed.

(vi) Outdoor signage shall be limited to building-mounted signs. Advertisement for cannabis or cannabis products is prohibited.

(vii) [Medical cannabis grower and/or processor] Cannabis grower is not permitted as an accessory use.

(D) Cannabis micro-grower

(i) The boundaries of property used for Cannabis micro-grower and/or processor uses shall be located a minimum of three hundred (300) feet from:

(aa) Any residential zone, including a residential comprehensive design zone under the prior ordinance;

(bb) A playground, recreation center, library, or public park; and

(cc) Any pre-existing primary or secondary school in the State, or pre-existing licensed childcare center or registered, pre-existing family childcare home pursuant to the Education Article, Annotated Code of Maryland.

(ii) Buildings, structures, and parking shall be located at least the following minimum distance from property lines:

(aa) the AG Zone, fifty (50) feet; and

(bb) In the IE Zone, twenty-five (25) feet.

(iii) Except for outdoor cultivations in the AG Zone pursuant to State licensing regulations, all aspects of the use shall be conducted within a fully enclosed building, in accordance with all applicable laws, rules, and regulations.

(iv) In the AG Zone, outdoor cultivation areas shall be located a minimum of fifty (50) feet from any street or property line and shall be fenced in accordance with applicable State licensing regulations. A planted bufferyard between the fence line and cultivations area shall be installed.

(v) Outdoor signage shall be limited to building-mounted signs. Advertisement for Cannabis or Cannabis products is prohibited.

(vi) Cannabis micro-grower is not permitted as an accessory use. However, it may co-locate with a Cannabis micro-dispensary and/or Cannabis micro-processor use within a facility operated by a Cannabis incubator.

(G) Cannabis Dispensary

(1) The boundaries of property used as a Medical Cannabis Dispensary shall be:

(aa) At least five hundred (500) feet from any existing or planned residential use, or property in a residential zone, including a residential comprehensive design zone under the prior ordinance;

(bb) At least five hundred (500) feet from any:

(I) Pre-existing primary or secondary school in the State; or a pre-existing licensed childcare center or registered, pre-existing family childcare home pursuant to the Education Article, Annotated Code of Maryland; or

(II) A playground, recreation center, library, or public park; and

(III) At least one thousand (1,000) feet from another Cannabis dispensary or Cannabis micro-dispensary.

(cc) At least two thousand (2,000) feet from any liquor store.

(2) Minimum parking requirements set forth in Section 27-6305 of this Subtitle are required.

(3) Cannabis dispensary is not permitted as an accessory use.

(4) Outdoor signage shall be limited to building-mounted signs. Advertisement for Cannabis or Cannabis products is prohibited.

(5) There shall be no on-site consumption of Cannabis or Cannabis products.

(6) The use shall be limited to twelve (12) business hours per day, between the hours of 8 a.m. and 10 p.m. All sales must be made and recorded during the hours of 8 a.m. and 10 p.m.

(7) The holder of a Special Exception for a Medical cannabis dispensary may operate as a Cannabis dispensary pursuant to that approved Special Exception and need not seek a new Special Exception approval for the Cannabis dispensary use, provided that the operator has converted the applicable State license to allow for the sale of both medical and adult use cannabis pursuant to the Alcoholic Beverages & Cannabis Article, Annotated Code of Maryland.

(GH) Cannabis micro-dispensary

(i) The boundaries of property used as a Cannabis micro-dispensary shall be:

(aa) At least three hundred (300) feet from any property in a residential zone, including a residential comprehensive design zone under the prior ordinance;

(bb) At least five hundred (500) feet from any:

(I) Pre-existing primary or secondary school in the State, or a pre-existing licensed childcare center or registered, pre-existing family childcare home pursuant to the Education Article, Annotated Code of Maryland; or

(II) A playground, recreation center, library, or public park; and

(cc) At least one thousand (1,000) feet from another Cannabis micro-dispensary or a Cannabis dispensary use.

(ii) Cannabis micro-dispensary is not permitted as an accessory use. However, it may co-locate with a Cannabis Micro-processor and/or Cannabis micro-grower use within a facility operated by a Cannabis incubator.

(iii) Outdoor signage shall be limited to building-mounted signs. Advertisement for Cannabis or Cannabis products is prohibited.

(i) The boundaries of property used for Cannabis processor uses shall be located a minimum of three hundred (300) feet from:

(aa) Any residential zone, including a residential comprehensive design zone under the prior ordinance;

(bb) A playground, recreation center, library, or public park; and

(cc) Any pre-existing primary or secondary school in the State, or a pre-existing licensed childcare center or registered, pre-existing family childcare home pursuant to the Education Article, Annotated Code of Maryland.

(ii) Buildings, structures, and parking shall be located at least the following minimum distance from property lines:

(aa) In the AG Zone, two hundred (200) feet;

(bb) In the IE Zone, fifty (50) feet.

(iii) In the AG Zone, the minimum net lot area is ten (10) acres.

(iv) All aspects of the use shall be conducted within a fully enclosed building, in accordance with all applicable laws, rules, and regulations.

(v) Outdoor signage shall be limited to building-mounted signs. Advertisement for Cannabis or Cannabis products is prohibited.

(vi) Cannabis processor is not permitted as an accessory use.

(F) Cannabis micro-processor

(i) The boundaries of property used for Cannabis micro-processor uses shall be located a minimum distance of three hundred (300) feet from:

(aa) Any residential zone, including a residential comprehensive design zone under the prior ordinance;

(bb) A playground, recreation center, library, or public park; and

(cc) Any pre-existing primary or secondary school in the State, or a pre-existing licensed childcare center or registered, pre-existing family childcare home pursuant to the Education Article, Annotated Code of Maryland.

(ii) Buildings, structures, and parking shall be located in the following minimum distance from property lines:

(aa) In the AG Zone, two hundred (200) feet; and

(bb.) In the IE Zone, fifty (50) feet.

(iii) All aspects of the use shall be conducted within a fully enclosed building, in accordance with all applicable laws, rules, and regulations.

(iv) Outdoor signage shall be limited to building-mounted signs. Advertisement for Cannabis or Cannabis products is prohibited.

SECTION 27-5400. SPECIAL EXCEPTION STANDARDS.

Sec. 27-5402. Additional Requirements for Specific Special Exception Uses.

(nn) [Medical cannabis dispensary] Reserved.

- [(1) The boundaries of property used as a medical cannabis dispensary shall be:]
 - [(A) At least three hundred (300) feet from any property in the AR, RE, RR, RSF-95, or RSF-65 zones;]
 - [(B) At least five hundred (500) feet from any land owned by the Maryland-National Capital Park and Planning Commission, unless the land has no recreational facilities within 500 feet of the dispensary property or there is a regulated stream or a County master plan roadway with a functional transportation classification as arterial or higher separating the recreational facilities from the property;]
 - [(C) At least five hundred (500) feet from any school land uses; and]
 - [(D) At least one (1) mile from any other medical cannabis dispensary use.]
- [(2) Minimum parking requirements for a medical cannabis dispensary shall be at least equivalent to the minimum parking requirements for a medical practitioner's office/medical clinic.]
- [(3) Medical cannabis dispensary is not permitted as an accessory use.]
- [(4) Outdoor signage shall be limited to building mounted signs and advertisement for cannabis or cannabis products is prohibited.]

1 SECTION 2. BE IT FURTHER ENACTED that the provisions of Section 27-5101, 27-
2 5102, and 27-6305 shall be renumbered or reordered, as appropriate, to accommodate the
3 incorporation of the provisions of this Ordinance and to be consistent with the tabulation
4 conventions within the Zoning Ordinance.

5 SECTION 3. BE IT FURTHER ENACTED the provisions of this Ordinance shall apply
6 prospectively. Any uses that were permitted and existing as of January 1, 2023, shall be deemed
7 permitted uses and not nonconforming uses.

8 SECTION 4. BE IT FURTHER ENACTED that the provisions of this Ordinance are
9 severable; and, in the event that any section, subsection, paragraph, subparagraph, sentence,
10 clause, phrase, or word of this Ordinance is declared invalid or unconstitutional by a court of
11 competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining
12 words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this
13 Ordinance, since the same would have been adopted without the incorporation in this Ordinance
14 of any such invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph,
15 subsection, or section.

1 SECTION 5. BE IT FURTHER ENACTED that this Ordinance shall take effect forty-five
2 (45) calendar days after its adoption.
