Maryland, that Section 30-309of the Prince George's County Code be and the same is hereby		
repealed and reenacted with the following amendments:

Sec. 30-309.	Easement terms and conditions.	
(a) Eacl	h conservation easement shall be in a form approved by the County Attorney, and	
shall contain, at a minimum, the following provisions:		
(1)	Restriction on division. The parcel shall be restricted from any further division	
except as may provided in the program regulations.		
(2)	No buy-back option. The owner shall not have the right to re-acquire the	
development potential extinguished by the easement.		
(3)	Agricultural uses. Agricultural uses shall be permitted on a parcel subject to a	
conservation easement.		

(4) Prohibited uses. Industrial or	r non-agricultural commercial uses shall not be
permitted on a parcel encumbered by a cons	ervation easement.
(5) Designation of Easement Hol	lders. The County shall be the easement holder of
each easement.	
(6) Non-publicly owned land. A	statement that the parcel on which the easement is
created is not publicly owned land.	
(b) The easements shall be recorded in	n the Land Records of the County and a copy of the
recorded easement shall be forwarded to the	Department of Environmental Resources Permit
Review Division.	
SECTION 2. BE IT FURTHER ENAC	CTED that this Act shall take effect forty-five (45)
calendar days after it becomes law.
