### **BACKGROUND INFORMATION/FISCAL IMPACT:**

This Resolution will direct the Planning Department staff of the Maryland-National Capital Park and Planning Commission to initiate and prepare, in accordance with the prescriptions of the Zoning Ordinance, a minor amendment to the 2010 *Central Annapolis Road Sector Plan and Sectional Map Amendment* to add a table of commercial uses permitted for properties in the development district with an underlying zoning classification in the C-S-C (Commercial Shopping Center) Zone.

The resolution also establishes, in accordance with Section 27-642 of the Zoning Ordinance, February 7, 2016, as the required joint public hearing date for the proposed minor amendment.
