### BILL

1 AN ACT concerning

2 County Real Property

3 For the purpose of declaring certain parcels of County-owned real property as surplus and no  
4 longer needed for County use.

5 WHEREAS, Section 2-111.01 of the Prince George's County Code requires that the County  
6 Executive shall establish an inventory of all real property and improvements titled in the name of  
7 Prince George's County and all real property and improvements to which Prince George's  
8 County has an equitable or fee simple title, such inventory to be presented to the County  
9 Council; and

10 WHEREAS, Section 2-111.01 of the Prince George's County Code further provides that the  
11 inventory of real property be reviewed at least once annually and that the County Executive  
12 shall transmit to the County Council for its approval by legislative act a list of the properties to  
13 be leased, offered for sale, or otherwise disposed of; and

14 WHEREAS, the County Executive transmitted to the County Council the 2025 Inventory of  
15 County-owned real property and improvements; and

16 WHEREAS, the County Executive has determined that certain parcels of property, which  
17 are owned by the County are not needed for County use and should be disposed of in  
18 accordance with Section 2-111.01 of the Prince George's County Code, as amended under CB-  
19 061-2023.

1        NOW, THEREFORE, BE IT ENACTED by the County Council of Prince George's County,  
2        Maryland, that the determination of the County Executive that parcels of property identified in  
3        Attachment A, attached hereto and made a part hereof, are surplus to the County's needs, be and  
4        the same is hereby approved.
