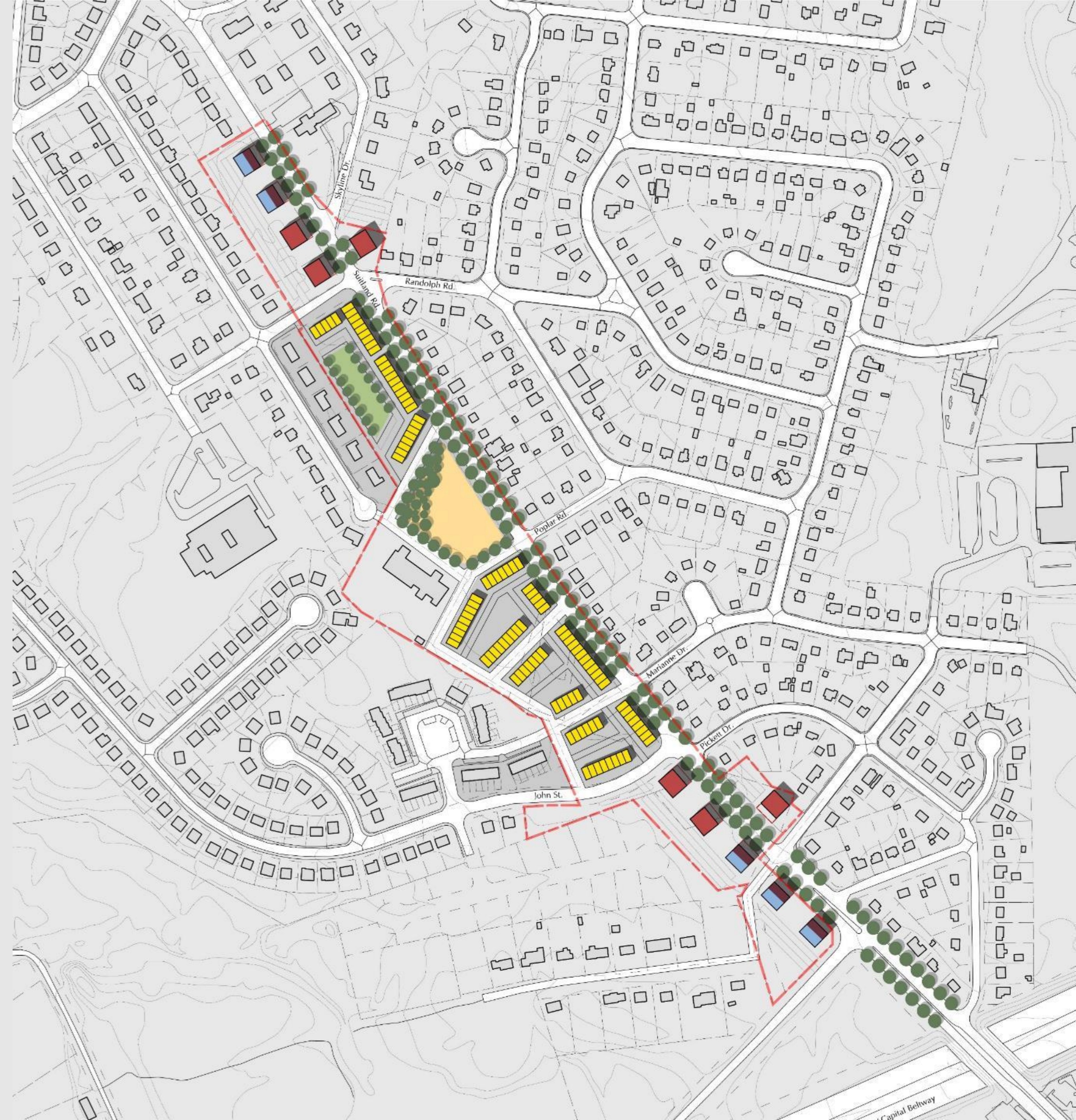

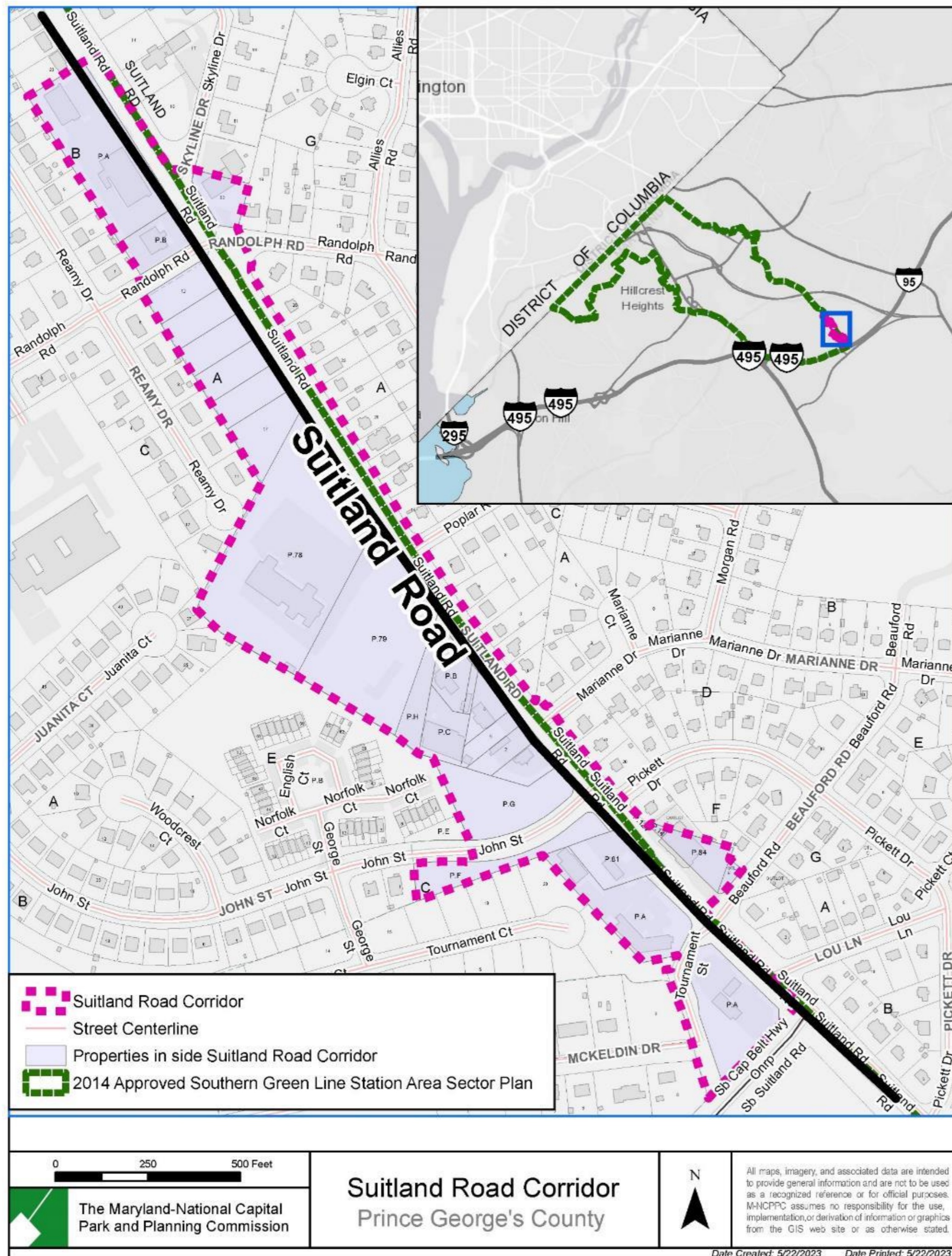

# PROJECT MAP

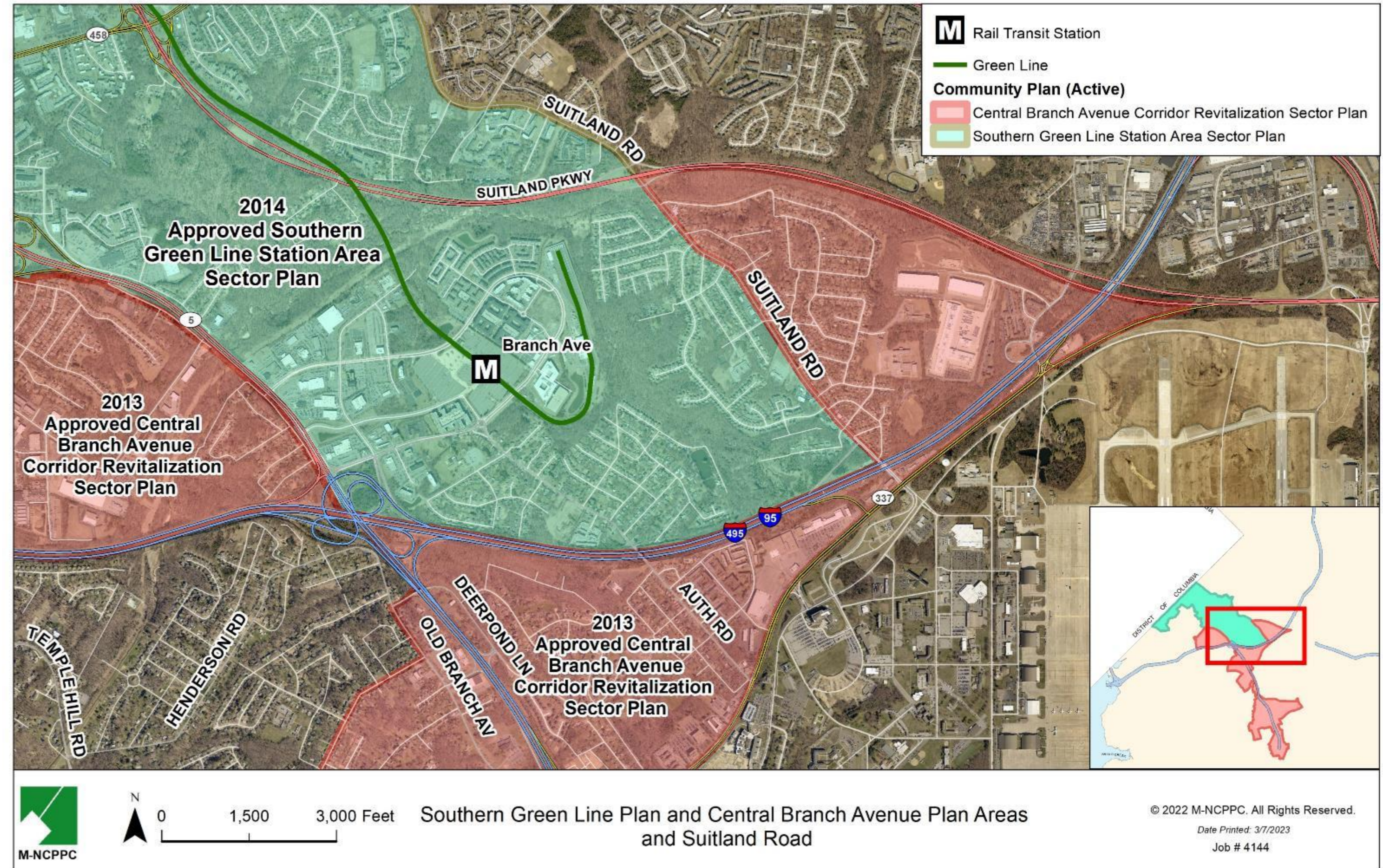
- 25.37 acres

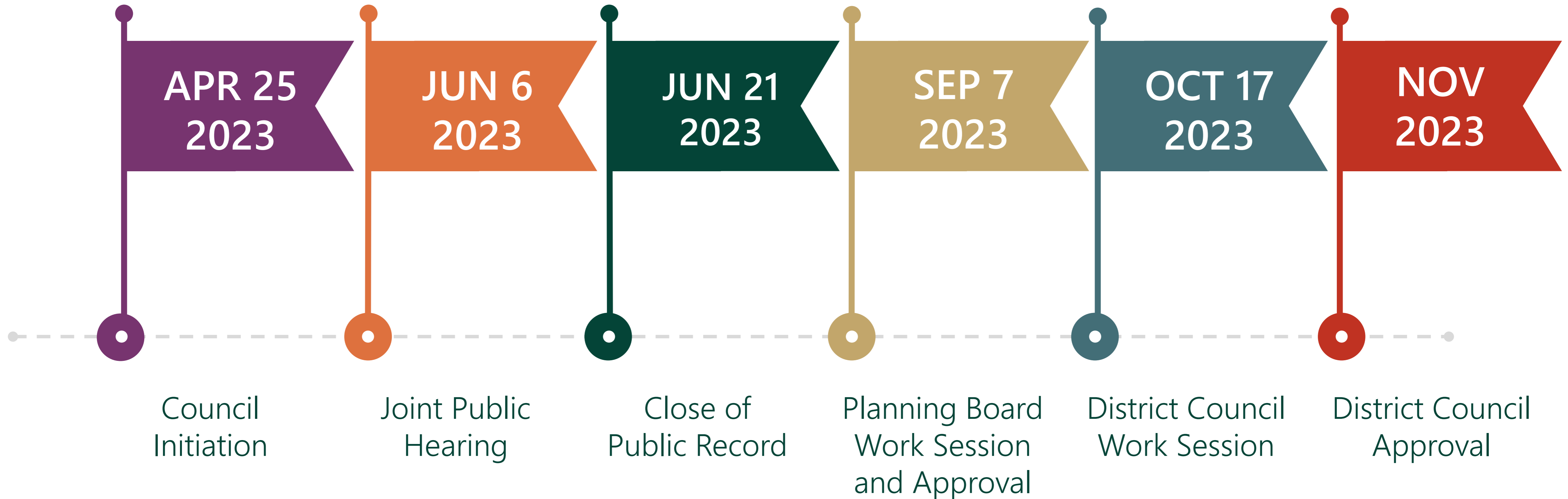
# MINOR PLAN AMENDMENT
