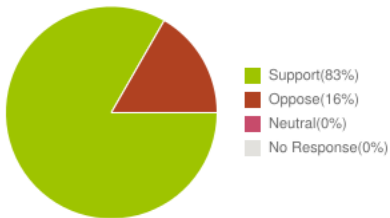

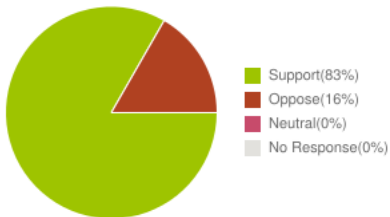

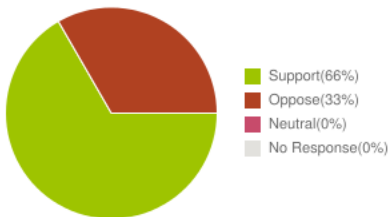

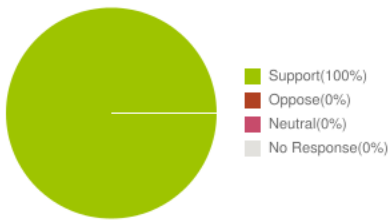
I support this bill because it will save lives in residential communities.
