## TRANSPORTATION, HOUSING AND ENVIRONMENT COMMITTEE DATE: 6/5/97

Committee Vote: Favorable as amended, 4-0 (In favor: Council Members Russell, Scott, Bailey, and Estepp).

This legislation will delete Section 26-140 of Prince George's County Code concerning the towing of vehicles parked in violation of the regulations and provisions established pursuant to this Division without prior notice pursuant to Division 18 of this Subtitle. Draft 1 would have modified the Code

permitting the Police Department to tow in a designated parking permit area without prior notice. Concern was expressed by the Legislative Officer about towing without prior notice. The Office of Law agreed to review that provision.

Stan Wildesen and George Chaktoura, Department of Environmental Resources, spoke in support of the legislation. They explained that this legislation was for the purpose of establishing and implementing a Parking Permit Area prior to the opening of the Redskins Stadium, thereby generating minimal impact on the Surrounding residential areas.

Lee Buchanan, representing Jim Odgers of the Parking Authority, supports the bill but recommends language enabling the County Executive to authorize the Parking Authority to enforce the provisions of Division 9. The Parking Authority has been requested to assist the Police with parking enforcement in residential Parking Permit Areas in the Stadium District during stadium events.

The Committee amended the bill by adding language authorizing the Parking Authority to enforce the provision of Division 9 and deleting Section 26-140(c). This necessitated a draft 2.

#### BACKGROUND INFORMATION/FISCAL IMPACT

This legislation will allow the County Executive to modify the traffic engineering survey required for certain County parking permit areas, setting a fine for parking in violation of the regulations and provisions set by the County Executive in a designated parking permit area, and authorizing the police to tow any vehicle parked in violation to such regulations or provisions.
