subdivision was appro	ed within the time limits specified in Section 24-119(e). In the R-R

1	Zone, and in the R-80 and R-55 Zones in cluster subdivisions for which the preliminary plan of		
2	subdivision was approved on or after September 1, 1986, only one-family detached dwellings are		
3	permitted. However, a church may be developed on a lot greater than two (2) acres within an		
4	approved cluster subdivision in the R-R Zone for which the preliminary plan of subdivision was		
5	approved on or after September 1, 1986. Approval of a Detailed Site Plan and architectural		
6	drawings (consisting of exterior elevations, and exterior finish materials) is required in		
7	accordance with Part 3, Division 9, Subdivision 3, of the Zoning Ordinance, prior to the issuance		
8	of any building or use and occupancy permit for the church.
