**RESOLUTION**

1 A RESOLUTION concerning

2 Envision Prince George's

3 For the purpose of expressing the support of the County Council for the vision, goals, and  
4 priorities established by the Envision Prince George's process and strategic plan for  
5 implementation

6 WHEREAS, the Maryland-National Capital Park and Planning Commission launched  
7 *Envision Prince George's* at the October 3, 2008, Economic Outlook Forum; and

8 WHEREAS, the Economic Outlook Forum is produced in partnership with the Prince  
9 George's County Economic Development Corporation; and

10 WHEREAS, the broader Prince George's community joined the efforts of *Envision Prince*  
11 *George's*; and

12 WHEREAS, *Envision Prince George's* is a call to action to develop and implement a vision  
13 for the future of Prince George's County with a vibrant economy and high quality of life for  
14 everyone; and

15 WHEREAS, *Envision Prince George's* has engaged thousands of Prince Georgians in  
16 multiple dialogues to develop a comprehensive countywide vision, goal priorities, and action  
17 strategies over an approximate twenty (20) month process; and

18 WHEREAS, the visioning process has culminated in recommendations for six *Envision*  
19 quality of life areas- Live, Work, Serve, Enjoy, and Sustain; and

20 WHEREAS, more than 1100 participants at the March 20, 2010, *Envision Prince George's*  
21 21<sup>st</sup> Century Town Meeting identified 13 priority goals under the six quality of life *Envision*  
22 areas; and

1 WHEREAS, Community Action Teams are now engaged in developing strategies to  
2 achieve the priority goals; and

3 WHEREAS, the continued economic success and quality of life for all Prince George's  
4 County communities are affected by the six *Envision* areas and priority goals; and

5 WHEREAS, a broad and diverse *Envision Prince George's* Implementation Coordinating  
6 Council is recommended to facilitate coordination between public, private, and civic sectors of  
7 Prince George's County to support the implementation, progress assessment, and continuous  
8 renewal of *Envision Prince George's* – its vision, goals, and action strategies; and

9 WHEREAS, the Prince George's County Council recognizes the importance and potential  
10 of the *Envision Prince George's* Implementation Coordinating Council to enhance coordination,  
11 resource development and deployment, program integration, and implementation at all levels;  
12 and

13 WHEREAS, securing and coordinating resources is an important element of sustainability.

14 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
15 County, Maryland, that the County Council actively supports and adopts the *Envision Prince*  
16 *George's* principles and process, and the overarching vision and priorities emanating from the  
17 process, and will participate as a public sector stakeholder and partner on the *Envision Prince*  
18 *George's* Implementation Coordinating Council.

19 BE IT FURTHER RESOLVED that the Council hereby adopts and pledges its support for  
20 the vision, goals, and priorities established from the *Envision Prince George's* process.

21 BE IT FURTHER RESOLVED that the Council will consider the action strategies and  
22 recommendations resulting from *Envision Prince George's* when making decision that affect the  
23 countywide vision.

24 BE IT FURTHER RESOLVED that the County Council hereby encourages the adoption of  
25 the vision, goals, and priorities of *Envision Prince George's* by each of the twenty-seven  
26 municipalities in Prince George's County and the various community and business organizations  
27 and other entities in the County with participation as partners by all Prince George's County  
28 stakeholders- individually and collectively.
