**RESOLUTION**

1 A RESOLUTION concerning

2                   The Enactment of Certain Ordinance of the City of Bowie

3 For the purpose of approving the enactment of Ordinance O-5-19 amending Chapter 26 of the  
4 Code of the City of Bowie, concerning municipal zoning authority.

5           WHEREAS, Section 25.301 of the Maryland Annotated Code states that the District  
6 Council may provide that the governing body of municipal corporation within the Maryland-  
7 Washington Metropolitan District may exercise certain powers of the District Council; and

8           WHEREAS, the District Council enacted CB-1-2019 to authorize the exercise of certain  
9 additional powers of the District Council by municipalities; and

10           WHEREAS, the City of Bowie passed Ordinance O-5-19 on June 1, 2019; and

11           WHEREAS, this Ordinance (which is attached hereto and incorporated herein as  
12 Attachment A, and hereinafter referred to "Ordinance O-5-19") amended the Code of the City of  
13 Bowie Chapter 26 to include additional municipal authority, notwithstanding any other law, to  
14 erect fences that exceed height restrictions or limitations otherwise required by State, Regional,  
15 or County zoning laws or agencies exercising zoning and planning jurisdiction over the  
16 municipal corporation; and to make further amendments to more fully comport with the Zoning  
17 Ordinance; and

18           WHEREAS, the City of Bowie, pursuant to Section 25.303 of the Maryland Annotated  
19 Code, has delivered certified copies of Ordinance O-5-19 to the District Council; and

20           WHEREAS, upon review of Ordinance O-5-19, the District Council has determined that  
21 Ordinance O-5-19 comports with the prescriptions of Section 27-924 of the Zoning Ordinance

1 concerning municipal powers.

2 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
3 County, Maryland, sitting as the District Council for that part of the Maryland-Washington  
4 Regional District in Prince George's County, Maryland, that Ordinance O-5-19 of the City of  
5 Bowie, as represented in Attachment A to this Resolution, be and the same is hereby approved.
