Pursuant to proper notice the public hearing was convened at 7:15 p.m. Leroy Maddox, Legislative Officer, provided a report of the actions and recommendations of the Committee of the Whole. Nathaniel Tutt, III, the County Executive's Liaison, indicated that Jacqueline Woody would provide the statement of the Local Development Council on this bill, to avoid any potential conflict. The Honorable Tony Knotts, Delegate, Legislative District, The Honorable Edward Burroughs, School Board Member, Juwon Blocker, Student School Board Member, Nicole Nelson, Andrew Campbell, III, Jasmine Blackwell, Brooke Blackwell, Dr. Valencia Campbell, Nathaniel Bryant, Tammy Jones, Johnny R. Toles, Jr., Jay Krueger, Rhonda Dallas, Zeno W. St. Cyr, II, Patricia Morris, Marsha Dabolt and Gerald Lucas provided verbal testimony. All persons wishing to speak having done so, the public hearing was declared held.

The public hearing was held for this Resolution.

Under discussion, Council Member Harrison spoke to her support for this measure as a mechanism to support the school system to assist Prince George's County students. Council Member Franklin applauded Council Member Patterson for his work on this issue and spoke to his support for technical and career programs. Council Member Glaros echoed concerns voiced by Council Member Harrison regarding the "no position" proffered by the Local Development Council. Council Member Turner thanked the citizenry and further explained the fund allocation process. He requested clarification regarding the impact of adopting Attachment B on the final legislation and the impact area radius. Robert Williams, Jr., Council Administrator, clarified that it was the intent of the motion made by Council Member Patterson to adopt the Proposed Spending Plan outlined in Attachment B rather than the one in Attachment A. Council Member Taveras

further spoke to the funding that may be available for other entities and programs in future years. Council Member Patterson sought to clarify potential funding and provided information about the process for requesting funding next year. Chairman Davis spoke to the efforts of the Council to safeguard the impact area and provide expanded opportunities for students.

A motion was made by Council Member Patterson, seconded by Council Member Franklin, that this Resolution be adopted. The motion carried by the following vote:
