**RESOLUTION**

1 A RESOLUTION concerning

2 Acting Health Officer for Prince George's County

3 For the purpose of extending the temporary appointment of Mr. Oluwasanmi O. Areola as the  
4 Acting Health Officer for Prince George's County.

5 WHEREAS, Section 505 of the Charter of Prince George's County, Maryland, provides for  
6 the County Executive to make a temporary appointment to the position of head of any agency of  
7 the Executive Branch if such a position shall become vacant; and

8 WHEREAS, Section 505 further provides that such appointment may be extended an  
9 additional four months by resolution of the County Council; and

10 WHEREAS, by Executive Order No. 1-2023, Mr. Oluwasanmi O. Areola was appointed as  
11 Acting Health Officer for Prince George's County, effective January 1, 2023.

12 WHEREAS, the temporary appointment of Mr. Oluwasanmi O. Areola as Health Officer  
13 for Prince George's County has been approved by the Maryland Department of Health.

14 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
15 County, Maryland, that the temporary appointment of Mr. Oluwasanmi O. Areola as Acting  
16 Health Officer for Prince George's County be and the same is hereby extended, for a period of up  
17 to four calendar months effective March 2, 2023, or until another appointment is made consistent  
18 with Section 12-101.01 of the Prince George's County Code of Ordinances, Maryland  
19 Annotated Code, Health-General, § 3-302 and the Charter of Prince George's County,  
20 Maryland.

21 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
22 County, Maryland, that the temporary appointment of Mr. Oluwasanmi O. Areola as Acting

1 Health Officer for Prince George’s County be and the same is hereby extended for a period of up  
2 to four calendar months effective March 2, 2023.
