## Transportation, Housing and Environment Committee November 7, 2013

Committee Vote: Favorable, 3-0 (In favor: Council Members Davis, Olson and Turner)

Staff provided a summary of the resolution and referral comments that were received. CR-116-2013 approves and adopts the Analysis of Impediments to Fair Housing Choice for Prince George's County pursuant to Federal law. The Analysis of Impediments to Fair Housing Choice serves as the basis for fair housing planning, provides essential information to governmental policy makers, private and not-for-profit organizations to support public support for fair housing efforts.

Eric Brown, Director, and Estelle Alexander, Deputy Director of the Department of Housing and Community Development, provided testimony in support of CR-116-2013 and answered questions from the Committee. Michael Lyles, Executive Director, Prince George's County Human Relations Commission, also provided additional information to the Committee.

The Office of Law determined that CR-116-2013 was in proper legislative form and no legal impediments to its adoption.
