3 For the purpose of prohibiting the County Executive and County Council Members from holding
4 a direct or indirect interest in, or being employed by MGM National Harbor, LLC for a certain
5 period of time after the termination of their service as the County Executive and a member of the

12 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
13 Maryland, that Sections 2-110.02 and 2-112.02.02 of the Prince George's County Code be and
14 the same are hereby added:

16 DIVISION 1. COUNTY COUNCIL.

17 **Sec. 2-110.02. Interest in or employment by MGM National Harbor, LLC.**

18 (a) No member of the County Council shall hold a direct or indirect interest in, or be
19 employed by, the MGM National Harbor, LLC for a period of three (3) years after the
20 termination of their service as a member of the County Council. The term "interest" shall be
21 defined pursuant to Section 2-291 of the County Code.

SUBTITLE 2. ADMINISTRATION.

DIVISION 2. COUNTY EXECUTIVE.

Sec. 2-112.02.02. Interest in or employment by MGM National Harbor, LLC.

(a) The County Executive shall not hold a direct or indirect interest in, or be employed by, the MGM National Harbor, LLC for a period of three (3) years after the termination of his service as the County Executive. The term "interest" shall be defined pursuant to Section 2-291 of the County Code.

SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law.
