## PUBLIC SAFETY & FISCAL MANAGEMENT COMMITTEE REPORT Date: 10/18/01

Committee Vote: Favorable, 3-0, (In favor: Councilmembers Bailey, Scott, and Maloney).

This resolution will amend the Salary Plan in Salary Schedule X for School Crossing Guards in the Police Department, represented by Council 67, AFSCME, AFL-CIO, Local 241, and reflects modifications of the two year agreement (FY2002-2003).

The highlights of the Salary Plan and the fiscal impact are included in CB-83-2001.
