RESOLUTION

1 A RESOLUTION concerning

2 Maryland-National Capital Park and Planning Commission

3 For the purpose of approving a certain transfer of appropriations within the Recreation Fund of
4 the Approved Fiscal Year 2026 Operating Budget of the Maryland-National Capital Park and
5 Planning Commission.

6 WHEREAS, the Annual Budget and Appropriations Ordinance for the Prince George’s
7 County portion of the Maryland-National Capital Park and Planning Commission for Fiscal Year
8 2026 was adopted on May 29, 2025, by the approval of CB-055-2025; and

9 WHEREAS, in adopting the Fiscal Year 2026 Budget, the County Council included
10 \$14,705,000 in the Recreation Fund for project charges to eligible organization for recreation
11 programming; and

12 WHEREAS, the County Council made further revisions to the FY 2026 Budget for the
13 Recreation Fund, by way of Council Resolution 130-2025, based on the changing needs of
14 organizations approved for project charge funding; and

15 WHEREAS, the County Council desires to reallocate resources to take advantage of
16 recreation programming opportunities which were not available at the time of allocation; and

17 WHEREAS, under the provisions of the Annotated Code of Maryland, Land Use Article,
18 Title 18, the budget may be amended by resolution by the respective County Councils on their
19 own initiative or at the request of the respective County Executives, and after public hearing
20 upon reasonable notice to the public.

21 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
22 County, Maryland, that the following adjustments to the Fiscal Year 2026 Budget for the

1 Maryland-National Capital Park and Planning Commission, Recreation Fund, as approved in
2 CB-055-2025 and further amended by CR-130-2025, are hereby made for the purposes set forth
3 above:

5 BE IT FURTHER RESOLVED that within fifteen (15) calendar days of the adoption of this
6 Resolution, Prince George’s County and the Maryland-National Capital Park and Planning
7 Commission (Commission) shall revise the Memorandum of Understanding (Agreement)
8 executed for Fiscal Year 2026 in accordance with the approved changes stated herein.

9 BE IT FURTHER RESOLVED that the Commission shall have fifteen (15) calendar days
10 to review and execute the Agreement in accordance with the provisions of this Resolution. In the
11 event that the Commission does not execute the Agreement within the fifteen-day period, the
12 Agreement shall be deemed approved.
