#### PUBLIC SAFETY & FISCAL MANAGEMENT COMMITTEE REPORT Date: 10/10/95

Committee Vote: Favorable, as amended, 3-0 (In favor: Council Members Estepp, Gourdine and Russell.)

This Emergency bill will amend the County Code provisions which regulate casino night events, change the organizational reporting dates, create a joint permit and establish a Gaming Permit Review Board.

The bill contains the following amendments:

#### 1. On Page 3:

Line 8, delete brackets and "12 Noon".

Line 11, delete brackets and "2 p.m.".

Line 12, delete brackets.

Line 14, delete "three (3)", insert "five (5)".

Line 15, delete bracket, delete "only on real property owned by".

Line 16, delete "the permittee or leased by the permittee from a non-profit organization".

Line 20, delete bracket

#### 2. On Page 4:

Line 4, after "(except tips)", insert "as authorized by state law".

#### 3. On Page 5:

Line 21, delete brackets, "October" and "beginning on October 1, 1996".

#### 4. On Page 6:

Line 6, delete "existing permittee", insert "eligible organizations";

delete "organization", insert "applicant".

Line 9, delete "Non-profit organizations applying", insert "applicants".

Line 12, delete "permittees", insert "Eligible Organizations".

Line 14, delete, "Non-profit organizations", insert "applicants".

Line 15, after "revenue", insert "No less than fifty percent (50%) of the revenues net of expenses shall be enured to the benefit of the subordinate joint permit holder."

Line 17, insert "eligible" before "organization".

5. On Page 7, insert a new Section 4 repealing the moratorium, and change numbers accordingly.
