**RESOLUTION**

1 A RESOLUTION concerning  
2 Maryland National-Capital Park and Planning Commission  
3 For the purpose of approving a certain transfer of appropriations within the Park and Recreation  
4 Funds of the Approved Fiscal Year 2026 Operating Budget of the Maryland-National Capital  
5 Park and Planning Commission.

6 WHEREAS, the Annual Budget and Appropriations Ordinance for the Prince George’s  
7 County portion of the Maryland-National Capital Park and Planning Commission for Fiscal Year  
8 2026 was adopted on May 29, 2025, by the approval of CB-055-2025; and

9 WHEREAS, in adopting the Fiscal Year 2026 Budget, the County Council included  
10 \$14,705,000 in the Recreation Fund for project charges to eligible organization for recreation  
11 programming; and

12 WHEREAS, in adopting the Fiscal Year 2026 Budget, the County Council also dedicated  
13 \$6,290,000 in additional funding within the Recreation Fund for new, innovative recreation  
14 programming and partnerships; and

15 WHEREAS, in adopting the Fiscal Year 2026 Budget, the County Council included  
16 \$6,799,300 in the Park Fund for project charges to eligible organization for park beautification  
17 and maintenance activities;

18 WHEREAS, the County Council made further revisions to the FY 2026 Budget for the  
19 Recreation Fund, by way of Council Resolution 130-2025, based on the changing needs of  
20 organizations approved for project charge funding; and

21 WHEREAS, the County Council desires to reallocate resources to take advantage of park  
22 and recreation programming opportunities which were not available at the time of allocation; and

1 WHEREAS, under the provisions of the Annotated Code of Maryland, Land Use Article,  
 2 Title 18, the budget may be amended by resolution by the respective County Councils on their  
 3 own initiative or at the request of the respective County Executives, and after public hearing  
 4 upon reasonable notice to the public.

5 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
 6 County, Maryland, that the following adjustments to the Fiscal Year 2026 Budget for the  
 7 Maryland-National Capital Park and Planning Commission, Recreation Fund, as approved in  
 8 CB-055-2025 and further amended by CR-130-2025, are hereby made for the purposes set forth  
 9 above:

3 Commission (Commission) shall revise the Memorandum of Understanding (Agreement)  
4 executed for Fiscal Year 2026 in accordance with the approved changes stated herein.

5 BE IT FURTHER RESOLVED that the Commission shall have fifteen (15) calendar days  
6 to review and execute the Agreement in accordance with the provisions of this Resolution. In the  
7 event that the Commission does not execute the Agreement within the fifteen-day period, the  
8 Agreement shall be deemed approved.
