BILL

AN ACT concerning

An Inter-project Transfer of Appropriations in the FY1997 Capital Budget For the purpose of transferring appropriations between capital projects in the amount of \$1,100,000 from the Contingency Fund to the Bus Mass Transit/Rail Mass Transit capital project.

WHEREAS, pursuant to the provisions of Section 818 of the Charter for Prince George's County, Maryland, the County Council may authorize, by legislative act, upon request of the County Executive, inter-project transfers of appropriations between capital projects in the Approved Capital Budget; and

WHEREAS, the County Executive deems it desirable to provide additional appropriations for the Bus Mass Transit/Rail Mass Transit project (FH668545) as currently existing appropriations are inadequate for project completion; and

WHEREAS, the County Executive recommends that appropriations can be transferred from the Contingency Funds, as an excess of appropriations over estimated costs is expected.

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that the Fiscal Year 1997 Approved Capital Budget is hereby amended, as shown on Attachments A and B, attached hereto, to provide that appropriations are transferred as follows:
