## Transportation, Housing and Environment Committee

April 28, 2016

<u>Committee Vote</u>: Favorable with amendments, 5-0 (In favor: Council Members Turner, Taveras, Davis, Lehman and Patterson)

The Transportation Housing and Environment Committee met on April 28, 2016 to discuss CR-16-2016, the FY 2017 Annual Action Plan. Staff explained the purpose of CR-16-2016, allocates the federal funding in Community Development Block Grant (CDBG) of \$4.5 million, CDBG Program Income - \$100,833 and Affordable Housing Funds including entitlement funds plus estimated Program Income - \$104,100. The HOME Investment Partnership was funded in the amount of \$1.6 million and the Emergency Shelter Grants in the amount of \$775,000. Under CDBG, there are maximum amounts allowed for Public Services Projects (15%), Program Planning and Administration (20%) and the remaining balance is allocated among the eligible activities, including economic development, affordable housing and public facilities, according to the 5-Year Consolidated Plan, adopted by CR-16-2016. A Technical amendment in Public Administration – Requested amount was \$618,591 corrected to \$716,363. Reallocations are as follows:

Mr. Eric Brown, Director and Ms. Estella Alexander, Deputy Director, of Housing and Community Development (DHCD), provided responses to questions posed by members of the Committee.

The Committee reviewed the Annual Action Plan, focusing on each of the above-mentioned categories and recommended the following changes as reflected in CR-16-2016 Draft 2.

The Office of Law finds that CR-16-2016 is in proper legislative form and saw no legal impediments to its adoption.

The Office of Audits & Investigations found that enactment of CR-16-2016 will not have a negative or adverse fiscal impact on the County since it deals with federal funds.
