RESOLUTION

A RESOLUTION concerning

Compensation and Benefits - Fraternal Order of Police

Prince George's County Lodge 89, Inc.

Salary Schedule L, Schedule of Pay Grades

FOR the purpose of amending the Salary Plan of the County to reflect the terms of a settlement agreement by and between Prince George's County and the Fraternal Order of Police Prince George's County Lodge 89, Inc.

WHEREAS, Prince George's County and the Fraternal Order of Police Prince George's County Lodge 89, Inc. have entered into a settlement agreement to resolve a dispute between the parties that has arisen under their July 1, 1996 through June 30, 1999 collective bargaining agreement concerning payment of newly hired officers; and

WHEREAS, pursuant to Section 903 of the Prince George's County Charter and Section 16-125(a) of the Prince George's County Code, amendments to the County's Salary Plan are to be submitted to the County Council in resolution form; and

WHEREAS, the Salary Plan must at this time be amended by the approval of a salary schedule to reflect the terms of a settlement agreement to discontinue the reduced salary rates received by newly hired police officers while attending the Police Academy and to make one-time, non-base payments of One Thousand Dollars (\$1,000) to police officers who received reduced rates of pay while attending the Police Academy; and

WHEREAS, pursuant to Section 1017 of the Prince George's County Charter, a resolution has the force and effect of law of a temporary or administrative nature;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the settlement agreement entered into between the County and the Fraternal Order of Police Prince George's County Lodge 89, Inc. is hereby approved and that Section V of Salary Schedule L is amended by the addition of the following:

FY98: Effective March 2, 1998, the reduced rate of pay referenced in the preceding sentence and received by newly hired officers while attending the Police Academy will be discontinued.

Further, any officer covered by this Agreement who is no longer attending the Police Academy as of March 2, 1998 and who received the above-referenced reduced rate of pay while attending the Police Academy will receive a one time, non-base payment of One Thousand Dollars (\$1,000) following approval by the County Council.
