SECTION 1. BE IT ENACTED by the County Council of Prince George's County,		
Maryland, sitting as the District Council for that part of the Maryland-Washington Regional		
District in Prince George's County, Maryland, that Section 27-113 of the Zoning Ordinance of		
Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code,		
be and the same is repealed and reenacted with the following amendments:

Sec. 27-113. Land conveyed by the United States of America or by the State of Maryland.

- (a) Any land which is conveyed in fee simple by the United States of America or by the State of Maryland shall immediately be placed in the Reserved Open Space (R-O-S) Zone until a Zoning Map Amendment for the land has been approved by the District Council. This Section shall not apply to land conveyed from the Maryland-National Capital Park and Planning Commission or land conveyed from the University of Maryland (or the State of Maryland as title owner for the University of Maryland) which is zoned R-55 and is adjacent to an existing residential subdivision for the purpose of creating thirty (30) lots or less.
- (b) A conveyance of land in fee simple by the United States of America or by the State of Maryland within nine (9) months of a final decision in a rezoning of the land through a Zoning Map Amendment shall be exempt from the provisions of Section 27-113(a), above.

SECTION 2. BE IT FURTHER ENACTED that this Ordinance shall take effect forty-five (45) calendar days after its adoption.
