WHEREAS, the	e County Council of Prince George's County, sitting as the District Council,
received a request from the Mayor of the Town of Riverdale Park to prepare a Mixed-Use Town	
Center (M-U-TC) Zoning Map Amendment for the Town of Riverdale Park and forwarded the	
request to the Prince George's County Planning Board; and	
WHEREAS, Se	ection 27-198.02 of the Zoning Ordinance provides that an Mixed-Use Town
Center Zoning Map Amendment may be initiated by the Planning Board only after concurrence	
(by resolution) of the	District Council; and
WHEREAS, the Planning Board approved staff's recommendation to prepare a Mixed-Use	
Town Center (M-U-TC) Zoning Map Amendment for the Town of Riverdale Park and to	
determine the appropriate area for mixed-use land uses and zoning in order to foster	
redevelopment and re	evitalization in the city; and
WHEREAS, the	e Zoning Ordinance provides that the District Council may zone property to
the Mixed-Use Town Center Zone only where an approved Master Plan recommends a Mixed-	
Use Town Center Zone, or where the area is an older, substantially developed, mixed-use	
community; and	
WHEREAS, the	e Approved Master Plan and Sectional Map Amendment for Planning Area

68 recommends the M-U-TC Zone for the Town of Riverdale Park, which is an older,

1 substantially developed, mixed-use community. 2 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's 3 County, Maryland, sitting as the District Council for that part of the Maryland-Washington Regional District in Prince George's County, Maryland, that the Maryland-National Capital Park 4 5 and Planning Commission is hereby directed to prepare an M-U-TC Zoning Map Amendment 6 for the Town of Riverdale Park, in accordance with the requirements of the Zoning Ordinance. 7 BE IT FURTHER RESOLVED that a joint public hearing on the M-U-TC Zoning Map 8 Amendment shall be held by the Planning Board and District Council and that the provisions of 9 Section 27-198.02 mandating separate public hearings by the Planning Board and District 10 Council shall not apply in this instance. 11 BE IT FURTHER RESOLVED that this Resolution shall take effect upon its adoption.
