<u>CB-16-2004 – AN ORDINANCE CONCERNING AMENDMENTS TO APPROVED</u>
<u>BASIC PLANS</u> for the purpose of authorizing amendments to approved Basic Plans under certain circumstances. <u>PRESENTED</u>

Council Bill 16 was presented and referred to Planning, Zoning and Economic Development Committee (PZED)

### <u>PROPOSED CORRESPONDENCE/ADMINISTRATIVE OFFICER'S REPORT – APPROVED; CHAIRMAN AUTHORIZED TO SIGN</u>

Robert Williams, Jr., Associate Council Administrator provided a verbal report on the actions and recommendations of the General Assembly Committee. Council Member Exum moved to adopt the General Assembly Report and authorized the Chairman's Signature on the transmittal letter; seconded by Council Member Dean. The motion carried 8-0. (Absent: Council Member Shapiro.

#### **SECOND READING OF BILLS (INTRODUCTION)**

<u>CB-11-2004 (DR-2) – AN ORDINANCE CONCERNING HOME OCCUPATIONS</u> for the purpose of defining low-impact home occupation and permitting the use in certain residential zones, amending the definition of home occupation, and making related amendments concerning home occupations.

### **INTRODUCED**

Council Member Dernoga as Chairman of the Planning, Zoning and Economic Development Committee (PZED) provided the Council Members with a verbal report of the Committee's actions and recommendations. Council Bill 11 amends the Zoning Ordinance to define "low-impact home occupations" and to permit the use in certain residential zones. The legislation also amends the definition of home occupation by deleting existing Section 27-445.11 pertaining to home occupations and by transferring the content of that Section to the definition of home occupation at Section 27-107.01(118). Council Bill 11 was favorably reported out of PZED on 03/17/2004 with amendments. Council Bill 11 was introduced by Council Members Dean, Exum, Knotts and Peters.

#### PUBLIC HEARINGS/BILLS ELIGIBLE FOR THIRD READING (ENACTMENT)

<u>CB-4-2004 – AN ORDINANCE CONCERNING PRISONS, DETENTION CENTERS</u>
<u>AND CORRECTION FACILITIES</u> for the purpose of amending the definitions in the Zoning Ordinance to add prisons and corrections facilities as a separate use and to prohibit the use in all zones. *PUBLIC HEARING HELD; ENACTED* 

Pursuant to proper notice, the public hearing convened on Council Bill 4. Rev. Douglas Edwards and Mr. Freddie Dawkins spoke in support of the legislation. All persons wishing to speak have done so, the public hearing was declared held. Council Member Dean moved to enact Council Bill 4; seconded by Council Member Harrington. The motion carried 8-0 (Absent: Council Member Shapiro).

#### RESOLUTIONS ELIGIBLE FOR FINAL READING (ADOPTION)

CR-15-2004 (DR-2) – A RESOLUTION CONCERNING THE 2001 WATER AND SEWER PLAN (DECEMBER 2003 CYCLE OF AMENDMENTS) for the purpose of changing the water and sewer category designations of properties within the 2001 Water and Sewer Plan. *DR-2 SUBSTITUTED*; ADOPTED

Council Member Harrington, as Chairman of the Transportation, Housing and the Environment Committee, (THE) provided a verbal report of the action and recommendations of the Committee. Council Member Hendershot moved to substitute Draft 2 of Council Resolution 15 in lieu of Draft 1; seconded by Council Member Harrington. The motion carried by voice vote. Absent: Council Member Shapiro). The motion carried 8-0 (Absent: Council Member Shapiro). Council Member Dean moved to adopt; seconded by Council Member Peters. Under discussion, Council Member Hendershot requested clarification of the relation to Adequate Public Facility 'ADF' regulation.
