**BACKGROUND INFORMATION/FISCAL IMPACT:**

On May 27, 2021, the Council enacted CB-34-2021, an Ordinance to adopt the Fiscal Year 2021-22 budget for the Maryland-National Park and Planning Commission for the portion of the Maryland-Washington Regional District in Prince George's County. Since the date of adoption, there is a need to amend the approved budget to correct a clerical error and transfer project charges from the Anacostia Watershed Society, Inc. (AWS), to the Anacostia Trails Heritage Area, Inc (ATHA). This Resolution will approve a transfer in the amount of \$20,000.00 from AWS to ATHA. No increase in overall expenditures will result from the adoption of the modification to the approved FY 2021-22 budget.
